

| | The World | | Global Warming and Climate Change: Step Up Action and Adapt to New Climate Reality: UN Environment Report | |



 provide real protection against droughts, floods and rising sea levels, a new UN Environment Report has found. According to the Adaptation Gap Report 2020, released on today, Thursday, January 14, by the UN Environment Programme:UNEP, as temperatures rise and climate change impacts intensify, nations, must, urgently, step up action to adapt to the new climate reality or face serious costs, damages and losses.



Annual adaptation costs in developing countries are estimated at \$70 billion but, the figure could reach up to \$300 billion in 2030 and \$500 billion in 2050. Almost, three-quarters of nations have some adaptation plans in place but, financing and implementation fall far short of what is needed, according to the UNEP Report. Stepping up public and private finance for adaptation is, therefore, urgently needed. Adaptation is a key pillar of the Paris Agreement on Climate Change. It aims to reduce countries' and communities' vulnerability to climate change by increasing their ability to absorb impacts.

"The hard truth is that climate change is upon us." Ms Inger Andersen, UNEP Executive Director, said in a news release announcing the findings. "Its impacts will intensify and hit vulnerable countries and communities the hardest, even, if, we meet the Paris Agreement goals of holding global warming this century to well below 02 degrees Celsius and pursuing 01.5 degree Celsius."

"As the Secretary-General has said, we need a global commitment to put half of all global climate finance towards adaptation in the next year. This will allow a huge step up in adaptation, in everything from early warning systems to resilient water resources to nature-based solutions." Ms Andersen said.

The UNEP Report, also, underscored the importance of nature-based solutions as low-cost options, that reduce climate risks, restore and protect biodiversity and bring benefits for communities and economies. Its analysis of four major climate and development funds: the Global Environment Facility:GEF, the Green Climate Fund:GCF, the Adaptation Fund and the International Climate Initiative:IKI, suggested that support for green initiatives with some element of nature-based solutions has risen over the last two decades.

Cumulative investment for climate change mitigation and adaptation projects under the four funds stands at \$94 billion. However, only \$12 billion was spent on nature-based solutions, a tiny fraction of total adaptation and conservation finance, it added. Cutting greenhouse gas emissions will reduce the impacts and costs, associated with climate change, according to the Report. Achieving the 02 degrees Celsius target of the Paris Agreement could limit losses in annual growth to up to 01.6%, compared to 02.2% for the 03 degrees Celsius trajectory.


UNEP urged all nations to pursue the efforts, outlined in its December 2020 Emissions Gap Report, which called for a green pandemic recovery and updated Nationally Determined Contributions:NDCs, that include new net-zero commitments. "However, the world must, also, plan for, finance and implement climate change adaptation to support those nations, least responsible for climate change but, most at risk."

"While the COVID-19 pandemic is expected to hit the ability of countries to adapt to climate change, investing in adaptation is a sound economic decision." The Report said.

|| Ecology || 2020: One of the Three Warmest Years on Record: World Meteorological Organisation ||



Il Thursday: January 14: 2021 Il $\dot{\alpha}$. The COVID-19 pandemic was not the only long-term crisis the world will remember from 2020. In terms of climate change, the year was, also, one of the three warmest on record and rivalled 2016 for the top spot, the UN weather agency said on Wednesday. "The confirmation by the World Meteorological Organisation:WMO that 2020 was one of the warmest years on record is yet another stark reminder of the relentless pace of climate change, which is destroying lives and livelihoods across our planet." said UN Secretary-General Mr António Guterres.

He pointed out that at 01.2 degrees of warming above pre-industrial levels, the world is already witnessing unprecedented weather extremes in every region and on every continent. "We are headed for a catastrophic temperature rise of 03 to 05 degrees Celsius this century." he warned. "Making peace with nature is the defining task of the 21st century. It must be the top priority for everyone, everywhere."

La Niña, which began in late last year, is expected to continue into the early-middle part of 2021. "The exceptional heat of 2020 is despite a La Niña event, which has a temporary cooling effect."

said WMO Secretary-General Professor Petteri Taalas. La Niña and El Niño effects on average global temperatures are typically strongest in the second year of the event.

"It is remarkable that temperatures in 2020 were virtually on a par with 2016, when we saw one of the strongest El Niño warming events on record. This is a clear indication that the global signal from human-induced climate change is now as powerful as the force of nature."

The extent to which the continued cooling effects of La Niña this year may temporarily diminish the overall long-term warming trend remains to be seen. WMO pointed to sustained heat and wildfires in Siberia, diminishing Arctic sea ice and record-breaking hurricanes in the Atlantic as being among the climate events that most stood out in 2020. WMO, also, reminded that temperature was just one climate change indicator. Greenhouse gas concentrations, ocean heat content, global mean sea level, sea ice extent and extreme events are, also, factors.

WMO's consolidated global temperature update incorporates information from five leading international sets of data. It, also, uses datasets, that combine millions of meteorological and marine observations, including, from satellites, with models to produce a complete reanalysis of the atmosphere. "The combination of observations with models makes it possible to estimate temperatures at any time and in any place across the globe, even, in data-sparse areas, such as, the polar regions." according to WMO.

The Paris Agreement aims to limit global warming to well below 02°C, preferably to 01.5°C degrees, compared to pre-industrial levels. However, the global average temperature in 2020 had already approached the lower limit of the temperature increase, that the Agreement seeks to avert. Moreover, there is, at least, a one-in-five chance that the average global temperature will temporarily exceed 01.5 °C by 2024, according to WMO's Global Annual to Decadal Climate Update, led by the United Kingdom's Met Office.

The 2021 Met Office annual global temperature forecast, also, suggests that next year will again be one of the earth's hottest years. Updating its provisional December report, WMO will issue its final publication in March, which will incorporate temperature figures, information on all leading climate indicators and selected climate impacts.

The Canada Infrastructure Bank:CIB and Oneida Energy Storage LP announced the signing of a Memorandum of Understanding for the Oneida Energy Storage project in Ontario. MOU confirms the CIB's collaboration with Oneida Energy Storage LPin support of the project. Representing the largest project of its kind in Canada, the proposed Oneida Energy Storage project includes the development of a 250megawatt:1000 megawatt-hour energy storage facility in Southwestern Ontario.

The CIB and Oneida Energy Storage LP have an agreement on the parameters around a CIB investment in the project, which will be confirmed by further due diligence and a final investment decision in spring 2021. This partnership is another step forward for the CIB to deliver new clean power infrastructure as part of its \$10 billion Growth Plan. Oneida Energy Storage LP is a joint venture between NRStor Incorporated and Six Nations of the Grand River Development Corporation.

The facility would provide clean, reliable power capacity. It would draw and store existing surplus baseload and renewable energy during off-peak periods. Power would be released to the Ontario grid when energy demand is at its peak. In addition, the energy storage facility would help stabilise Ontario's electricity sector by providing important grid balancing services.

By helping to better use the existing assets of Ontario customers, greater efficiencies would be secured leading to a more affordable and cost-effective electricity system. The CIB engages and builds relationships with all levels of government, indigenous communities and private and

institutional investors. Its team of infrastructure experts conduct market analysis and provide specialised commercial and investment expertise, including, innovative financial modelling, project structuring and procurement options to support project sponsors.

"The CIB is excited to be part of this project as it has the potential to deliver sustainable, reliable and affordable energy for customers in Ontario. The project is founded on a strong partnership between an innovative Canadian energy company and a First Nation community. The CIB is proud to support this partnership. As part of the Growth Plan, the CIB has a goal of investing \$02.5 billion in clean energy projects across Canada within three years. The CIB will continue to encourage projects which include meaningful Indigenous community participation." said Mr Ehren Cory, CEO, Canada Infrastructure Bank.

"Energy storage is a game-changer, that can help to enable Canada's transition to a low-carbon economy and make Ontario a global leader in cleantech innovation. We are excited to work with industry-leading partners on the Oneida project to deliver grid efficiencies at scale resulting in meaningful savings for rate payers. We believe Oneida will be just the first of many exciting storage projects on our country's horizon." said Ms Annette Verschuren, CEO and Founder, NRStor.

| | Political Economics | | The European Bank for Reconstruction and Development Grants \$100 Million For Jordan's Green Finance | |

The European Bank for Reconstruction and Development: EBRD is providing Jordan's National Electric Power Company: NEPCO with a US\$100 million financing package to help the firm address working capital constraints by replacing short-term debt financing borrowed at the first peak of the Covid-19 crisis in the spring with a longer-term facility.

The proceeds will support NEPCO's financial position. With funding from the Swiss State Secretariat for Economic Affairs:SECO, the EBRD will, also, support NEPCO in an apprenticeship programme to promote career opportunities for women and young professionals, taking the opportunity of this pandemic-related support to build a more inclusive energy sector.

In 2014, Jordan embarked on a very ambitious renewable energy programme. By 2020, the country had exceeded its original renewable energy target of 10% of generated energy, with the figure now standing at 20%. Jordan is working towards a new goal of 30% by 2030.

NEPCO is the key actor in the energy sector as it owns and operates the electricity transmission system. The company has been at the heart of Jordan's renewable energy transition, using private capital and skills to unlock the country's wind and solar resources.

Since the start of its operations in Jordan in 2012, the EBRD has provided close to €01.4 billion in 58 projects, including, more than €535 million in 14 loans to projects in the country's energy sector.

| | Asia | | Israel: Ensure Equal COVID-19 Vaccine Access to Palestinians: UN Special Rapporteurs | |

Israel's 'impressive' vaccination programme against the COVID-19 pandemic must include Palestinians under occupation, UN independent human rights experts stressed on Wednesday. "In this early stage of the worldwide inoculation programme, Israel has delivered the vaccines to a higher percentage of its citizens than any other country." said UN Special Rapporteurs Mr Michael Lynk and Ms Tlaleng Mofokeng.

While noting that Israel has offered Palestinians with resident status in occupied East Jerusalem the vaccines, they noted, however, that it had not ensured that those under occupation in the West Bank and Gaza would have any near-future access to the vaccine. As coronavirus infections and deaths continue to rise steadily, the World Health Organisation:WHO) noted that since March, more than 160,000 Palestinians in the occupied Palestinian territory:OPT had tested positive and over 1,700 had succumbed to COVID-19.

And as the coronavirus continues to ravage the West Bank and Gaza, fracturing an already badly under-resourced Palestinian health care system, the UN experts drew specific attention to the deteriorating health situation in Gaza, which is already facing a 13-year-old blockade, serious water and electricity shortages, and endemic poverty and unemployment.

The Special Rapporteurs indicated that COVID-19 vaccines ordered separately by the Palestinian Authority may not be delivered to the West Bank and Gaza en masse for many weeks. This means that more than 04.5 million Palestinians will remain unprotected and exposed to COVID-19, while Israeli citizens, living near and among them, including, the Israeli settler population will be vaccinated.

"Morally and legally, this differential access to necessary health care in the midst of the worst global health crisis in a century is unacceptable. Israel is required under the Fourth Geneva Convention to maintain health services in the occupied territory." the rights experts have said. "The right to health is, also, a fundamental human rights issue." they referring to international human rights law, that stipulates the entitlement of everyone to 'the highest attainable standard of physical and mental health'.

"The denial of an equal access to health care, such as, on the basis of ethnicity or race, is discriminatory and unlawful" said the UN experts. The Special Rapporteurs, also, called on the Palestinian Authority and de facto administration in Gaza to co-operate with Israel in implementing a comprehensive OPT vaccination programme.

"It will only be through the sustained effort by all the governing authorities with the common goal of a comprehensive vaccination programme on the basis of equality and best-practices, that the prospect for the defeat of the pandemic will be possible." they said. Also noting that the Israeli Public Security Ministry instructed the Israeli Prison Service to not vaccinate Palestinian security prisoners, the experts recalled that due to the high risk of inmate infections, Israeli health authorities had previously given instructions for all prisoners in Israeli custody to be prioritised for vaccinations.

Special Rapporteur Mr Lynk covers the situation of human rights in the Palestinian Territory, occupied since 1967 and Ms Mofokeng safeguards the right to health. Special Rapporteurs are appointed by the Geneva-based UN Human Rights Council to examine and report back on a specific country situation. The experts are not UN staff nor are they paid for their work.

| | United Kingdom | | Travel From South American Destinations Portugal Panama and Cape Verde Are Banned to Prevent the Spread of New Variant | |



Il Thursday: January 14: 2021 Il $\dot{\alpha}$. The UK Government has taken the urgent decision to ban travel to the UK from several South American destinations, Portugal, Panama and Cape Verde, in order to prevent the spread of a new strain of coronavirus, COVID-19, into the country. From 04:00 on Friday, January 15, passengers, who have been in or transited through Argentina, Brazil, Bolivia, Chile, Cape Verde, Colombia, Ecuador, French Guiana, Guyana, Paraguay, Panama, Portugal, including, Madeira and the Azores, Peru, Suriname, Uruguay and Venezuela in the last 10 days will no longer be granted access to the UK.

This does not include British and Irish Nationals or any third country nationals with residence rights in the UK, who will be able to enter the UK but are required to self-isolate for 10 days on arrival along with their household. There will, also, be a flight ban on any countries with direct flights to England. These are Argentina, Brazil, Cape Verde and Portugal, including, Madeira and the Azores. This excludes cargo and freight without passengers.

The decision to ban travel from these destinations follows the discovery of a new coronavirus variant, first identified in Brazil, that, may have spread to countries with strong travel links to Brazil. The UK does currently not have travel corridors with Argentina, Brazil, Bolivia, Cape Verde, Colombia, Ecuador, French Guiana, Guyana, Panama, Paraguay, Peru, Portugal, Suriname, Uruguay and Venezuela but the travel corridors with Chile, Madeira and the Azores will be closed. Anyone returning from these countries from 04:00 on Friday will be legally required to self-isolate for ten days.

Any exemptions, usually, in place, including, for those related to employment, will not apply; although, hauliers, who have been in or transited through Portugal only in the last 10 days will be exempt to allow transport of essential goods.

Passengers arriving in England from Argentina, Brazil, Bolivia, Chile, Cape Verde, Colombia, Ecuador, French Guiana, Guyana, Paraguay, Panama, Portugal, Peru, Suriname, Uruguay and Venezuela after the scheduled time of the travel ban on January 15 can not be released from self-isolation and but only through Test to Release.

People, who share a household with anyone, self-isolating after returning from Argentina, Brazil, Bolivia, Chile, Cape Verde, Colombia, Ecuador, French Guiana, Guyana, Paraguay, Panama, Portugal, Peru, Suriname, Uruguay and Venezuela will now, also, need to self-isolate until 10 days have passed since anyone they live with was last in those countries.

From Monday, January 18 at 04:00, passengers from all destinations will, also, be required to present a negative COVID-19 test result before travelling to England, to help protect against new strains of coronavirus, circulating internationally and to identify those, who, may, currently be infectious.

National restrictions for England, introduced on January 06 remain in place, meaning everyone must stay at home unless travelling for a very limited set of reasons, including, for work. This means people can no longer travel to take holidays or travel internationally unless for work or other legally permitted reasons. Those in breach of the rules face penalties, starting at £200, rising to a maximum of £6,400.

The UK government is working closely with international partners to understand the changes in the virus, that have been reported in these countries and it is conducting a programme of further research here in the UK to inform the risk assessments.

|| England || More Than a Third of Over 80s Have Been Vaccinated Against COVID-19 ||



Il Thursday: January 14: 2021 Il α . More than one third, 34.6%, 1,036,605, of people, aged 80 and over, in England have received, at least, one dose of the COVID-19 vaccine as of January 10, new surveillance data from Public Health England:PHE shows. Older people are more likely to die from COVID-19, which is why they are being prioritised for vaccination. Over 80s are in the second priority group after care home residents and staff, as recommended by the independent Joint Committee on Vaccination and Immunisation:JCVI.

A further 960,699, 01.7%, people under 80 have, also, had the first dose of the vaccine. As well as uptake by age, PHE's new weekly report includes a breakdown of coverage by region, which is the percentage of all eligible people, who have been vaccinated. More high-quality data will become available in the coming weeks to provide further insight into groups where uptake of the vaccine can be increased.

Coverage is an important public health measure as it helps us to determine how well the population is protected as a whole and to look at where we should be focusing our efforts to increase uptake.

PHE will continue to monitor the long-term safety, uptake and efficacy of the COVID-19 vaccine. Data on under-vaccinated groups, the impact of vaccination on cases, hospitalisations and death, the effectiveness of the vaccine at preventing disease and transmission, as well as, the duration of protection will be published in future reports.

Dr Mary Ramsay, the Head of Immunisation at PHE, said, "To have vaccinated over a third of all over 80s by this point in the programme is a great achievement and I want to pay tribute to all those across the health system, who have made this happen.

Although, this sets us on the right path to getting back to normal life, we are not there yet and people must continue to follow the guidance, that is in place to protect themselves and their loved ones.


