**|| The Humanion || ILO Launches the International Year for the Elimination of Child Labour to Encourage Legislative and Practical Actions to Eradicate Child Labour From the World ||**



|| Sunday: January 17: 2021 || á. Although, child labour has decreased significantly over the last decade, one-in-ten children are still caught up in harmful work, the International Labour Organisation:ILO said on Friday, beginning a year-long bid to eradicate the brutal practice. "There

is no place for child labour in society.” said Mr Guy Ryder, the Director-General of ILO. “It robs children of their future and keeps families in poverty.”

While the number children in child labour has dropped from 246 million in 2,000 to 152 million in 2016, ILO noted the uneven progress across regions. It pointed to some 72 million children, working in Africa, which account for, almost, half of the world’s total. This is followed by Asia and the Pacific, home to 62 million child labourers. ILO highlighted that 70% of these children work in agriculture, mainly, in subsistence and commercial farming and livestock herding.

Almost, half of these child labourers are in occupations or situations, considered hazardous to their health and lives. Meanwhile, the COVID-19 pandemic has considerably exacerbated the situation by rendering everyone more vulnerable to exploitation, compounding poverty within defenseless populations and jeopardising hard-fought gains in the fight against child labour.

Furthermore, school closures have pushed millions more children into the labour market, so they can contribute to the family income. “With COVID-19 threatening to reverse years of progress, we need to deliver on promises now more than ever.” said Mr Ryder.

On a positive note, ILO said that joint and decisive action could reverse this trend. In collaboration with the Alliance 8.7 global partnership, ILO launched the International Year for the Elimination of Child Labour to encourage legislative and practical actions to eradicate child labour worldwide. Adopted by the General Assembly in 2019, the year aims to urge governments to work towards achieving Target 8.7 of the Sustainable Development Goals.

Target 8.7 calls for immediate measures to end forced labour, modern slavery and human trafficking while, also, eliminating the worst forms of child labour, including, the use of child soldiers and by 2025 ending child labour in all its forms.

The 12-month campaign will, also, prepare the ground for the fifth Global Conference on Child Labour in 2022, which will welcome additional commitments towards ending child labour in all its forms by 2025 and forced labour, human trafficking and modern slavery by 2030.

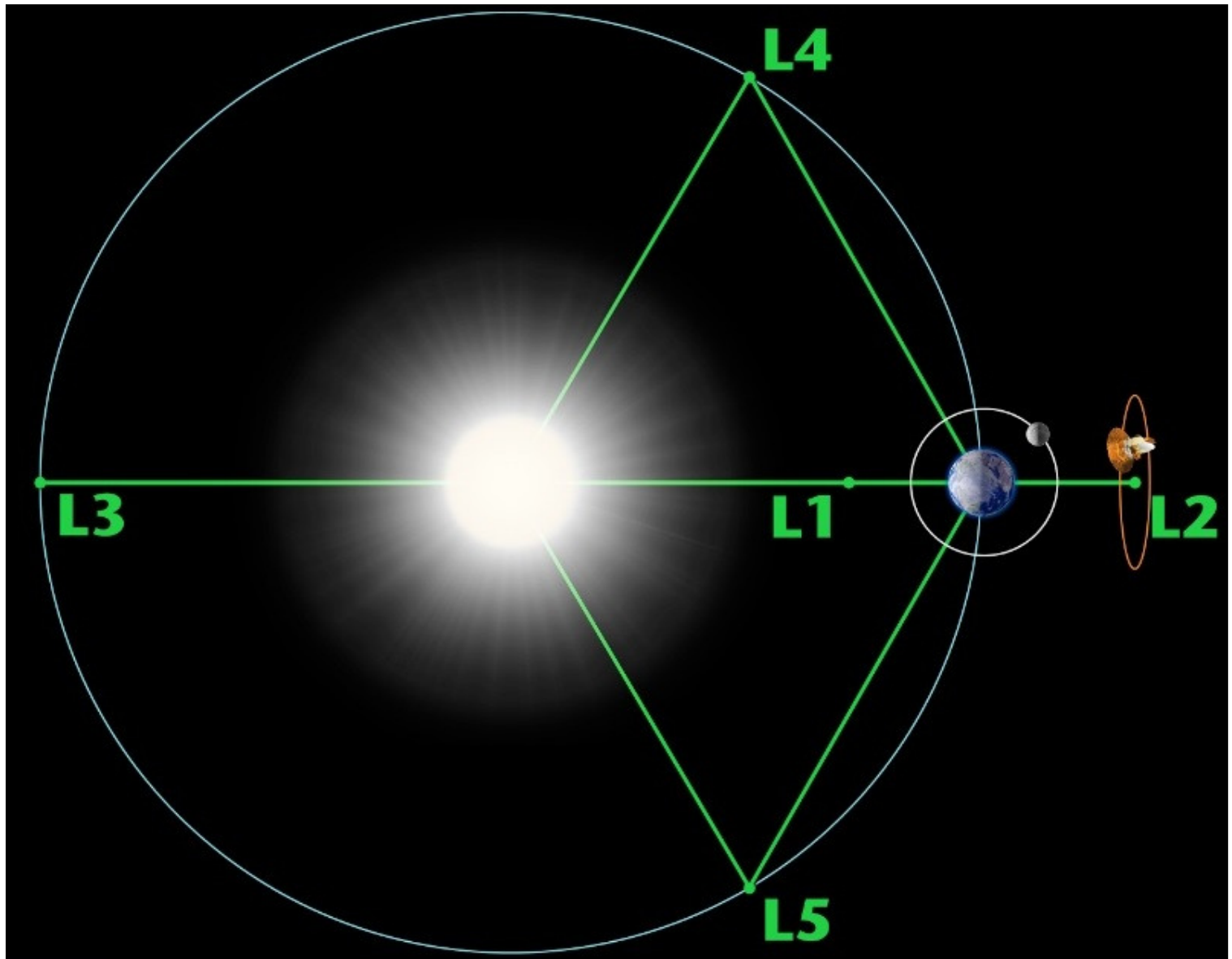
“This International Year is an opportunity for governments to step up and achieve Target 8.7 of the Sustainable Development Goals by taking concrete actions to eliminate child labour for good.” ILO said.

**|| The World || Iran’s Preparation to Produce Uranium Metal: France Germany and United Kingdom Strongly Urge Iran to Halt This Activity and Return to Compliance With the Joint Comprehensive Plan of Action ||**





|| Sunday: January 17: 2021 || ႁ. The Governments of France, Germany and United Kingdom have strongly urged Iran to halt the activities of seeking to produce uranium metal and return to compliance with its Joint Comprehensive Plan of Action:JCPoA.

In a joint statement the three Government said that their governments were deeply concerned by Iran's announcement that it was preparing to produce uranium metal.

The joint statement went onto say that Iran had no credible civilian use for uranium metal. The production of uranium metal had, potentially, grave military implications.

Under the Joint Comprehensive Plan of Action:JCPoA, Iran had committed to not engaging in production of uranium metal or conducting research and development on uranium metallurgy for 15 years.

"We strongly urge Iran to halt this activity and return to compliance with its JCPoA commitments without further delay, if, it is serious about preserving the deal."

## **|| Political Economics || Over \$50 Billion in Gas Power Projects and LNG Import Facilities are at Risk of Cancellation in Baangladesh Pakistan and Vietnam: Time to Fully Turn Towards Renewables ||**

Emerging markets, such as, Vietnam, Pakistan and Baangladesh, that are turning to liquefied natural gas:LNG as a source of power are likely to be hit by higher and more volatile prices, according to a new briefing note from the Institute for Energy Economics and Financial Analysis:IEEFA. The Author of the note an LNG:Gas Analyst Mr Bruce Robertson says that new gas-fired power plants and LNG import facilities, totalling over US\$50 billion are at high risk of cancellation as gas-fired electricity becomes unaffordable in emerging markets.

“Asian LNG spot prices have soared to a new high on the back of stronger than expected seasonal demand for heating as freezing weather grips large parts of the northern hemisphere.” says Mr Robertson. “Interruptions to supply in Malaysia, Australia and the US, three of the world’s largest LNG exporters and higher freight rates have, also, affected prices.” The average LNG price for the February 2021 delivery into northeast Asia is estimated to be around \$21.45 per million British thermal units:mmBtu, according to pricing agency SandP Global Platts, up 47% from the previous week, \$14.60, source: Reuters.

A recent spot LNG cargo out of the Gorgon project in Western Australia was sold at ‘an incredible price of about \$US37 per million British thermal units, more than 18 times higher than the price about six months ago’, according to the Australian Financial Review. Mr Robertson points out that recent spot price volatility has led to tenders being cancelled by Baangladesh and Pakistan.

“Emerging markets are, particularly, price sensitive and will find the forthcoming gas price environment challenging, as we have already seen in Baangladesh and Pakistan. Higher and volatile LNG prices will make operating LNG-powered generation plants more costly and unpredictable. This, may, lead to the under-utilisation of LNG plants and rising gas and electricity tariffs for customers.”

According to Mr Robertson, the recent spot price rise may be a precursor to higher and more volatile gas prices in the future, with less affordable contract prices a likely outcome. “While contract gas prices have been low and relatively stable in recent years, this is unlikely to last.” says Mr Robertson. “With lower levels of drilling, financial instability in the oil and gas industry and low levels of industry investment, it is likely that a new era of higher prices and more volatility is upon us.”

According to Mr Robertson, the oil price, on which a lot of gas contracts are based, has been very low for a considerable length of time. If, the global economy does bounce back from the COVID-19 crisis, there could be considerably higher gas contract prices out of Australia, Qatar and the other big exporters. “Production has been severely curtailed, particularly, in the US where gas is sold, based on local US spot prices. “We expect US spot prices to rise considerably, potentially, doubling or, even, tripling due to the fact that production has been so low.” says Mr Robertson.

“Prices on the Henry Hub gas exchange, the US gas price benchmark, are about to be unsettled by a combination of oil and gas bankruptcies, the poor financial state of oil and gas companies and a lack of drilling in the US. We may be coming to the end of an era of stable gas prices and the effects of this will reverberate globally as the US now a major exporter.”

Mr Robertson says that for Asian power utilities, this could mean the prospect of under-utilisation of their LNG generation plants in the coming year. “The emerging markets of Vietnam, Pakistan and Bangladesh have over US\$50 billion of proposed gas-fired power projects at risk of cancellation from unaffordable LNG prices. The extreme volatility of spot prices combined with the increasing volatility of contract prices will see many projects become unbankable.

“In the end, this uncertainty will flow through to electricity customers, who will be looking at the possibility of rising tariffs. Asian countries should be looking to deflationary renewable energy as a cheaper, more predictable alternative resource to LNG.”

**|| Jurisprudence || Belarus: Leaked Audio Allegedly Expose Senior Interior Ministry Official Ordering the Use of Illegal Force Against the Peaceful Protesters Must Be Effectively Investigated: Amnesty International ||**

"Of the string of incriminating leaks, showing that Belarusian authorities crushed peaceful protest through pre-meditated human rights violations, this recording, if, authentic, is the most damning. It must be immediately, impartially and effectively investigated."

Reacting to the publication of an audio recording, in which one of the most senior Interior Ministry officials in Belarus, apparently, gives criminal orders to police to use unlawful force against peaceful protesters and disregard international law, Mr Denis Krivosheev, Amnesty International's Deputy Director for Eastern Europe and Central Asia, said.

"If, a top-level police officer is telling his force to target rubber bullets at testicles, stomachs and faces and, if, he is proposing the creation of internment camps for the most active protesters, plus, implying that their deaths would merely rid the country of people it does not need, then, under international law he is ordering the commitment of crimes." Mr Krivosheev said.

"The voice in the recording, also, refers to direct instructions from 'the head of state.' This begs the question of how his comments can be effectively investigated in Belarus. However, the state is responsible for investigating violations of human rights law and prosecuting those, reasonably suspected in fair trial proceedings. We demand nothing less."

BYPOL, a group, formed by Belarusian police officers, who quit the force in response to its use to crush peaceful protest, published a recording allegedly, featuring the voice of current Deputy



Interior Minister, Mr Mikalai Karpenkau, speaking to his subordinates sometime in October 2020. At the time he was in charge of the Interior Ministry’s Main Directorate for Combating Organised Crime and Corruption.

The recording contains numerous statements which, if, true, directly incriminate the police force in human rights violations, including, the death of peaceful protester Alyaksandr Taraykouski on August 10, 2020, who died from a lethal wound when security forces fired a rubber bullet directly at his chest.

**|| Political Economics || Air Travel Is Down 60%: The Airline Industry Losses Reach \$370 Billion: ICAO ||**

A new Report from the United Nations’ air transportation agency, the International Civil Aviation Organisation:ICAO, confirms that there was a dramatic fall in international air travel due to COVID-19, of around 60% over the course of last year, to levels last seen in 2003. ICAO said on Friday, that as seating capacity fell by around 50% last year, that left just 01.8 billion passengers, taking flights through 2020, compared with around 04.5 billion in 2019. ICAO said that the regional breakdown in losses showed a \$120 billion loss year-on-year in the Asia-Pacific region, \$100 billion in Europe, \$88 billion in North America, followed by \$26 billion, \$22 billion and \$14 billion in Latin America and the Caribbean, the Middle East and Africa, respectively. That adds up to a staggering financial loss to the industry of around \$370 billion, with airports and air navigation service providers lose a further 115 billion and 13 billion, respectively.

As the coronavirus began its global spread, the air industry came to a virtual standstill by the end of March. Following widespread national lockdowns, by April the overall number of passengers had fallen 92% from 2019 levels, an average of the 98% drop-off seen in international traffic and 87% fall in domestic air travel.

There was a moderate rebound during the summer travel period but, the recovery was short-lived. Sectoral recovery became more vulnerable and volatile again during the last four months of 2020, indicating an overall double-dip recession for the year. The Report notes that a persistent disparity between domestic and international air travel impacts resulting from the more stringent international measures in force.

Domestic travel proved more resilient and was the main driver of any glimmer of recovery to the industry, particularly, in China and Russia, ICAO notes, where domestic passenger numbers have already returned to the pre-pandemic levels. Overall, there was a 50% drop in domestic passenger traffic globally, while international traffic fell by 74% or around 01.4 billion passengers.

The plunge in traffic has put the entire industry's financial liability into question said ICAO and this threatens the viability of millions of associated jobs around the world. It has, also, severely impacted global tourism, given that more than 50% of international travellers used to reach their destinations by planes.

Air travel in 2020 was down 60% compared to the previous year due to the COVID-19 pandemic. The agency described the near term outlook as one of prolonged depressed demand, with downside risks to global air travel recovery predominating in the first quarter of 2021 and likely to be subject to further deterioration.

ICAO does not expect any improvement until the second quarter of 2021, although, this will still be subject to the effectiveness of pandemic management and vaccination roll out across the world. In the most optimistic scenario, said ICAO, by June of 2021 passenger numbers will be expected to recover globally to 71% of their 2019 levels or 53% for international and 84% for domestic flights. A more pessimistic scenario foresees, only, a 49% recovery, 26% for international and 66% in domestic.

ICAO will continue to provide recommendations and support for the aviation sector to weather the crisis. Its new Guidance on Economic and Financial Measures summarises a range of measures, that can be explored by states and the industry to ease the crisis and strengthen the industry to withstand future shocks better.

**|| North America: USA || The Biden-Harris Administration In the First Ten Days in Office: To Fight COVID-19: Build the Economy Back Better: Combat Systemic Racism and Inequality: And Address the Existential Threat of the Climate Crisis: Lead America Back Into the World ||**

The Incoming White House Chief of Staff of the new President-Elect Mr Ron Klain has issued a Memo to the Incoming White House Senior Staff, that presented a flurry of things, that the new President will do in the first ten days of taking office, on Wednesday, January 20. Mr Klain wrote, "President-elect Biden is assuming the presidency in a moment of profound crisis for our nation. We face four overlapping and compounding crises: the COVID-19 crisis, the resulting economic crisis, the climate crisis and a racial equity crisis.

All of these crises demand urgent action. In his first ten days in office, President-elect Biden will take decisive action to address these four crises, prevent other urgent and irreversible harms, and restore America's place in the world." On Inauguration Day, Mr Biden will sign, roughly, a dozen actions to combat the four crises, that his Administration has taken a determination to deal with so to 'restore humanity to the US immigration system and make government function for the people'. He will ask the Department of Education to extend the existing pause on student loan payments and interest for millions of Americans with federal student loans, re-join the Paris Agreement and reverse the Muslim Ban.

The President-Elect will launch his '100 Day Masking Challenge' by issuing a mask mandate on federal property and inter-state travel, part of a critical effort to begin to bend the curve on COVID. And, he will take action to extend nationwide restrictions on evictions and foreclosures and provide more than 25 million Americans greater stability, instead of living on the edge every month.

On January 21, the President-Elect will sign a number of executive actions to move aggressively to change the course of the COVID-19 crisis and safely re-open schools and businesses, including, by taking action to mitigate the spread through expanding testing, protecting workers and establishing clear public health standards. On January 22, Mr will direct his Cabinet agencies to take immediate action to deliver economic relief to working families, bearing the brunt of this crisis.

Between January 25 and February 01, he will sign additional executive actions, memoranda and Cabinet directives. The President-Elect will fulfil his promises to strengthen Buy American provisions 'so the future of America is made in America'. He will take significant early actions to advance equity and support communities of diverse ethnic backgrounds and other underserved communities. He will take action to begin fulfilling campaign promises, related to reforming the criminal justice system.

The President-Elect will sign additional executive actions to address the climate crisis with the urgency the science demands and ensure that science guides the Administration's decision making. Mr Biden will take the first steps to expand access to health care, including, for low-income women and women of ethnic backgrounds. He will fulfil his promises to restore dignity to the immigration system and the border policies and start 'the difficult but critical work of reuniting families separated at the border'.

"And, the President-Elect Biden will demonstrate that America is back and take action to restore America's place in the world." Mr Klain wrote. During the campaign, Mr Biden pledged to take immediate action to start addressing these crises and build back better. As President, he will keep those promises and sign dozens of executive orders, presidential memoranda and directives to Cabinet agencies in fulfilment of the promises he made.

"These executive actions will deliver relief to the millions of Americans, that are struggling in the face of these crises. President-Elect Biden will take action not just to reverse the gravest damages of the Trump Administration but, also, to start moving our country forward. These actions will change the course of COVID-19, combat climate change, promote racial equity and support other underserved communities and rebuild our economy in ways, that strengthen the backbone of this country: the working men and women, who built our nation. While the policy objectives in these executive actions are bold, I want to be clear: the legal theory behind them is well-founded and represents a restoration of an appropriate, constitutional role for the President."

"Full achievement of the Biden-Harris Administration's policy objectives requires not just the executive actions the President-Elect has promised to take but, also, robust Congressional action.

The President-Elect made the case for his first major legislative proposal earlier this week and will continue to advance legislative solutions to critical problems, such as, in the immigration bill he will send to Congress on his first day in office; the build back better recovery proposal to create millions of good-paying union jobs, that he will unveil in the coming weeks; and his on-going support for legislation related to voting rights, the minimum wage, combatting violence against women, and more.” Mr Klain wrote.

“As noted above, this list is not comprehensive. More items and more details will be forthcoming in the days ahead. Of course, these actions are just the start of our work. Much more will need to be done to fight COVID-19, build our economy back better, combat systemic racism and inequality and address the existential threat of the climate crisis. But by February 1st, America will be moving in the right direction on all four of these challenges and more.” Mr Klain wrote.

**|| Asia || Palestinian Authority Announces Parliamentary Elections in May and Presidential in July ||**

The Palestinian Authority President Mr Mahmoud Abbas has announced on Friday, the first full parliamentary and presidential elections in 15 years, scheduled to begin in May. The last elections, taking place across all the areas under control of the Palestinian Authority:PA, which has limited self-rule over the Israeli-occupied West Bank, while the militant



group Hamas controls the Israeli-blockaded Gaza Strip and Israel controls occupied East Jerusalem, were in 2006.

A year later, Hamas won at the ballot box in legislative elections and took military control of Gaza and in the process it ousted its rivals Fatah. Fatah continued to have majority support across the West Bank, leading to a longstanding rift with Hamas. Pressure has been growing on Palestinian leaders to reconcile across political and regional divides, according to news reports, following the stalemate with Israel over peace negotiations and diplomatic agreements reached in recent months between Israel and four Arab nations.

The UN Secretary-General Mr António Guterres has welcomed Friday's announcement by Mr Abbas. "The holding of elections in the occupied West Bank, including, East Jerusalem and Gaza will be a crucial step towards Palestinian unity." Mr Guterres said in a statement. He expressed hopes that it would give renewed legitimacy to national institutions, including, a democratically elected Parliament and Government in Palestine."

He expressed hope that the planned parliamentary elections in May and presidential elections in July, would contribute to restarting a process towards a negotiated two-state solution, based on the pre-1967 lines and in accordance with relevant UN resolutions, bi-lateral agreements and international law. He said that the UN stood ready to support all efforts on the part of Palestinians to be able to exercise their full democratic rights.

Mr Guterres, also, called on the Palestinian authorities to facilitate, strengthen and support women's political participation throughout the electoral cycle."

According to news reports, Friday's announcement from Mr Abbas' office has instructed the election committee and all state apparatuses to begin the election process across the entire Palestinian homeland. Hamas in Gaza, reportedly, reacted to the announcement positively, calling for fair elections and a vote 'without restrictions or pressures'.

**|| England || New Laws to Protect England's Cultural and Historic Heritage: Our Task Is to Study and Learn From History and Not to Demolish and Destroy It Even If Historic Something Makes Our Skin Scroll With Disgust: Nor Should We Let History to Be Made Into Mythologies For Political Purposes ||**



|| Sunday: January 17: 2021 || α. New laws to protect England's cultural and historic heritage have been announced by Communities Secretary Mr Robert Jenrick today, Sunday, January 17. The new legal protections mean that historic statues should be 'retained and explained' for future generations. Individuals, who want to remove any historic statue, whether listed or not, will now require listed building consent or planning permission. It is a timely decision for in these volatile times it is absolutely necessary to state the principle and stand guard of it: that our task is to study and learn from history and not to demolish and destroy it, even, if, historic something makes our skin scroll with disgust.

For once the things people of today do not like or hate or disapprove of any history or its parts and they demolish and crush them and take them out of existence, we face the serious dangers of losing our very 'reality reference point' so that our reality looks like a vandalised space and time where most of the 'signs, symbols and acts' of previous humanity were taken down. History requires not taking down but preservation and study so that we can learn about it so that we can see what humanity did horrendous and how and why and that provides us resolve to keep trying to not get there, not reach such horror or ugliness.

Without that in our sight we face the dangers from all directions. For Humanity as a kind has most of its existence in history, in the past than in its present. For who or what is Albert Monday unless he knows who his parents were, his grandparents were, great grandparents were and where they

lived, with what kind of people lived alongside them around the society they shared, how they lived, what kind of community they lived in, what kind of society they lived in and what kind of jobs they did, what kind educational institutions they went for getting an education, etc? What did they do when not working?

And, chances are, the father away into the past Albert Monday goes in his search of knowledge of his past, his history, the more he would come to find things, that he would not like, that he would hate, that much of it would make him sick and uncomfortable! So, what does he do: destroy and burn everything! But, there must be a public debate as to those, historic objects, those heritage objects, that represent some fundamental issues, that can not be ignored and there must be cultural and educational efforts to state the history as it stands. History must be left to be exactly that: history. It must not be let to be made into mythologies for political purposes.

Under the new regulations, if, the council intends to grant permission for removal of a particular statue and Historic England objects, the Communities Secretary will be notified so he can make the final decision about the application in question. Historic England and the Secretary of State will apply the new policy of 'retain and explain', meaning historic statues will only be removed in the most exceptional circumstances.

Many unlisted heritage assets are of interest, significance and pride to the local communities in which they are erected and it is right that protections are put in place for them. These new laws will protect 20,000 statues and monuments throughout England for future generations. These landmark legal changes come in the tradition of previous landmark heritage protection laws, such as, the Civic Amenities Act 1967 and the Town and Country Planning Act 1947.

The Communities Secretary Mr Robert Jenrick MP said, "For hundreds of years, public statues and monuments have been erected across the country to celebrate individuals and great moments in British history. They reflected the people's preferences at the time, not a single, official narrative or doctrine.

They are hugely varied, some loved, some reviled but, all part of the weft and weave of our uniquely rich history and built environment. We can not and should not now try to edit or censor our past. That's why I am changing the law to protect historic monuments and ensure, we don't repeat the errors of previous generations, losing our inheritance of the past without proper care."

The Culture Secretary Mr Oliver Dowden MP said, "I strongly believe that we should learn from our past in order to retain and explain our rich history. The decisions we make now will shape the environment inherited by our children and grandchildren. It is our duty to preserve our culture and heritage for future generations and these new laws will help to do so."

The new rules will, also, apply to unlisted historic plaques, memorials or monuments, which will, also, require planning permission and Historic England to be informed.

## **|| England || English Social Care to Receive £269 Million New Funding to Boost Staff Levels and Testing ||**

The impact of the new coronavirus variant is being felt across the country, with staff absence rates rising sharply both in care homes and among home care staff, due to testing positive or having to self-isolate. The funding announced today of £269 million will protect and support the social care sector, including, care homes and domiciliary care providers in England by increasing workforce capacity and increasing testing.

The vital infection prevention and control guidance on staff movement in care homes is, also, being reinforced, with a reminder to providers to continue following the rules and keep staff and residents safe. The new £120 million funding will help local authorities to boost staffing levels, a direct ask of the sector. The funding can: provide additional care staff where shortages arise, support administrative tasks so experienced and skilled staff can focus on providing care and help

existing staff to take on additional hours, if, they wish with overtime payments or by covering childcare costs.

The Health and Social Care Secretary Mr Matt Hancock said, "This funding will bolster staffing numbers in a controlled and safe way, whilst ensuring people continue to receive the highest quality of care. Since the start of the pandemic, we have taken steps to protect care homes, including, increasing the testing available for staff and residents, providing free PPE and investing billions of pounds of additional funding for infection control."

"Help is on the way with the offer of a vaccine, with over 40% of elderly care home residents having already received their first dose. Many local authorities across the country already have staffing initiatives in place to increase capacity and address staffing issues. These include care worker staff banks where new recruits are paid during training, re-deployment models where DBS checked staff are trained and moved into operational roles, and end-to-end training and recruitment services. The new £120 million fund will ensure such initiatives can continue and help other local authorities implement similar schemes." Mr Hancock said.

He said that the £120 million fund was in addition to the £149 million announced in December, which would be used to support rapid testing of staff testing and facilitate visits from family and friends where possible. The funding would help care home providers with the costs incurred, including, setting up safe testing areas, providing staff training and will contribute towards staff time spent administering and receiving tests.

"This £149 million grant is ring-fenced for lateral flow device testing in adult social care. Local authorities will be required to pass on 80% of the funding to care homes on a per beds basis, with 20% used at the local authorities discretion to support the care sector in delivering additional lateral flow device testing. All the funding will be available later this month, so local authorities can take action quickly to respond to the pandemic."

The Minister for Care Ms Helen Whately said, "This additional funding gives a boost to the social care workforce during some of the most difficult days of this pandemic so far. Care workers have been doing the most amazing job throughout the pandemic. In challenging circumstances, they have been caring for some of the people most at risk from this virus with compassion and skill.

This additional £120 million will support social care to cope where there are pressing staff shortages due to the pandemic and comes on top of the £149 million to support safer testing. We're continuing to listen to care providers to make sure they have the help they need, from free PPE to extra testing, along with all the work to vaccinate care home residents, staff and the wider social care workforce."

Increased staff testing remains a critical part reducing transmission. Care homes currently have access to three tests per week for their staff, with daily testing for seven days in the event of a positive case to protect staff and residents. Care homes will have additional lateral flow devices to test individuals working in more than one setting before the start of every shift.

Restricting staff movement remains critical to minimising the risk of transmission. In response to the government’s consultation, the sector called for an increase in staffing capacity instead of regulation to achieve this goal.

Professor Martin Green OBE, CEO of Care England, said, “As the largest representative body for independent providers of adult social care, Care England, is pleased the government listened to the sector regarding their deep concerns about banning staff movement. We want to work with the department to ensure the staff capacity fund delivers to the front line and is suitably flexible to reflect the crisis whereby providers are struggling with staff illness and absenteeism in the same way as their colleagues in the NHS are.”

Mr Vic Rayner, the Chief Executive of the National Care Form said, “It is positive that the government has taken note of the extreme staffing pressure that care providers across the country are experiencing. The funding announced and confirmed today is welcome news, but must be subject to continuous review. Communities across the country desperately need care organisations to be properly supported now and in the future so that they are ready and able to face every twist and turn of this pandemic. Around 40% of people, aged, 80 and over and a quarter of older care home residents have now received their first vaccine dose. By the end of next week, we aim to have offered a jab to all care home residents and staff.”
