Hednesday: February 17: 2021 He $\dot{\alpha}$. International partners, working to achieve equitable distribution of COVID-19 vaccines appealed on Wednesday for the UN Security Council to ensure people caught in conflict have access to these lifesaving treatments. Addressing the virtual meeting,

the UN Secretary-General Mr António Guterres described the goal of providing vaccines to all as the biggest moral test before the global community, underlining that everyone, everywhere must be included.

"Defeating COVID-19, now that we have begun to have the scientific capacity to do so, is more important than ever." he said. "Yet, progress on vaccinations has been wildly uneven and unfair. Just 10 countries have administered 75% of all COVID-19 vaccines. Meanwhile, more than 130 countries have not received a single dose. Those affected by conflict and insecurity are at particular risk of being left behind."

Mr Guterres said that the UN and its partners established the COVAX Facility so that all countries will have access to vaccines, regardless of their wealth. The global mechanism must be fully funded. "But we must do, even, more. The world urgently needs a Global Vaccination Plan to bring together all those with the required power, scientific expertise and production and financial capacities."

Mr Guterres proposed that the world's richest countries, the G20 nations, form an Emergency Task Force to prepare the plan and co-ordinate its implementation and financing. The task force would work to mobilise pharmaceutical companies and key industry and logistics actors. He underlined the UN's readiness to support this effort.

The UN Children's Fund UNICEF is assisting countries in preparation for COVID-19 vaccine distribution, aiming to procure two billion doses by the end of the year. "This historic effort deserves historic support." said Ms Henrietta Fore, UNICEF Executive Director. "Help us ensure that the light at the end of the tunnel shines on us all, including, the families and communities enduring the horrors of conflict."

Ms Fore underscored that the Council's support was necessary for getting countries to ensure that all people were included in national vaccination plans, regardless of their status or if they live in areas not under government control. She further highlighted the need for a global ceasefire, in line with the Secretary-General's appeal issued last March, while immunisation campaigns against measles, polio and other diseases, which were paused during the pandemic, must also resume.

"We can not allow the fight against one deadly disease to cause us to lose ground in the fight against others." she said.

The COVAX facility, also, includes a proposed safety net to provide vaccines for high-risk populations in humanitarian settings, according to Dr Seth Berkley, CEO at GAVI, the vaccine alliance. He stressed that this buffer was a measure of last resort. "I ask that the UN Security Council reinforce this message so that available doses are distributed to ensure truly equitable access, in accordance with the humanitarian principles and in upholding state obligations towards populations within their territory." he said.

The Secretary General of the International Federation of Red Cross and Red Crescent Societies:IFRC, also, briefed the Council. Mr Jagan Chapagain, spoke of the importance of fostering

trust amid high levels of vaccine hesitancy. He said that communities could clearly see the inequalities and unfairness in COVID-19 vaccine access.

"The fair and equitable distribution of vaccines is essential to building trust and for maintaining international peace and preventing violence. This is about more than fairness. This is about stopping the virus."

| | The World | | Strengthen One Health Approach to Prevent Future Pandemics: WHO Director-General | |



Health of humans, animals and eco-systems, as zoonotic diseases spread between animals and people, said the Director-General of the World Health Organisation:WHO on Wednesday. "While the concept of One Health, where multiple sectors communicate and work together to achieve better public health outcomes, may have once seemed simple, it is no longer." Dr Tedros Adhanom Ghebreyesus said, opening the 27th Tripartite Annual Executive Committee Meeting World Organisation for Animal Health:OIE.

"We can only prevent future pandemics with an integrated One Health approach to public health, animal health and the environment we share. Now is the time to take our partnership to a new level." Dr Tedros maintained that to keep people safe, One Health must be translated into local-

level systems. He pointed out that, approximately, 70% of all emerging and re-emerging pathogens are zoonotic, jumping from animals to humans. "We don't know when the next threat, the next disease X, will emerge. It is clear, however, that One Health must be about more than zoonoses."

"We can not protect human health without considering the impact of human activities, that disrupt eco-systems, encroach on habitats and further drive climate change." These activities include pollution, large-scale deforestation, intensified livestock production and the misuse of antibiotics, along with how the world produces, consumes and trades food.

As set out in the WHO Manifesto for a healthy and green recovery from COVID-19, the UN health agency supports a greater One Health emphasis on connections to the environment. "Paradoxically, the COVID-19 pandemic is giving us a unique opportunity to drive real change." said the top WHO official, noting that One Health will be the focus of upcoming G7 and G20 meetings.

He flagged the need for more science, better data and bolder policies across multiple sectors, with a whole-of-government and whole-of-society approach. "Expectations for the Tripartite and the need for effective collaboration, have never been higher." he said. Citing closer collaborative efforts at regional and country levels and progress in joint areas of work, including, the launch of the United Against Rabies forum, Dr Tedros said that advances were, also, being made in establishing governance structures to curb antimicrobial resistance and noted that the Global Leaders Group held its first meeting earlier this year.


He said that WHO would support and host the secretariat of a One Health High Level Expert Council, which will advise the expanded Tripartite members on action priorities, building consensus and collaboration. "We, also, need to ensure that all partner organisations have the resources to play this role jointly."

The Tripartite consists of WHO, OIE and the Food and Agriculture Organisation:FAO with the UN Environment Programming:UNEP joining this year. For its part, WHO will scale up investment and work through its disease programmes and technical networks to strengthen the One Health workforce for outbreak alert and response.

"We are at a critical juncture. We must build on this momentum to strengthen the One Health approach, with public health and disease prevention as its central pillar." Dr Tedros underscored. He concluded by saying, "If, the pandemic has taught us anything, it's that we're stronger together."

| | Jurisprudence | | Belarus: Crackdown Escalates | |

Belarusian law enforcement officials carried out a nationwide wave of raids, targeting human rights defenders and journalists on February 16, 2021, rounding up, at least, 40 people and searching their homes and offices, Human Rights Watch said today. Many of those targeted, have documented or reported on on-going mass protests or provided assistance to people in custody on politically motivated charges and to their families.

The Belarusian Investigative Committee, a law enforcement agency, responsible for criminal investigations, stated that the searches had targeted groups 'positioning themselves as human rights organisations' with the stated purpose of 'establishing the circumstances of the financing of the protests'. The raids are part of a criminal investigation under article 342 of the Belarus Criminal Code, organisation and:or participation in activities, that grossly violate public order, the agency said.

"These raids are part of a blatant intimidation campaign." said Mr Hugh Williamson, Europe and Central Asia Director at Human Rights Watch. "Belarusian authorities are targeting human rights defenders and independent journalists, apparently trying to eviscerate what's left of Belarus' civil society." The raids took place a week before the February 22 start of the 46th session of the UN

Human Rights Council in Geneva, where the crackdown in Belarus in the wake of the August 09, 2020 presidential election is on the agenda.

Human Rights Council members should adopt a resolution at the upcoming session condemning the abuses committed since the August presidential election, providing for robust monitoring and reporting on Belarus and calling for those responsible for violations to be held accountable, Human Rights Watch said.

The police raids began in the early hours of February 16 and continued throughout the day. Among those searched and detained were dozens of human rights defenders, journalists and members of independent trade unions from Minsk, Vitsebsk, Homyel, Mazyr, Mahiliou and other places. Groups, whose offices were raided include Viasna Human Rights Centre, the Belarusian Association of Journalists, Barys Zvozskau Belarusian Human Rights House and Belarus Solidarity Foundation.

Most of the activists and journalists rounded up were released. Several are still believed by their colleagues to be in custody as they have not been able to make contact with them. During the searches, law enforcement agents confiscated equipment, including, cameras, memory sticks, hard drives and laptops, as well as, bank cards, documents and cash.

"They took our equipment to prevent us from filming, to scare us and to scare others." a journalist, whose house was searched, told Human Rights Watch. The journalist said that during the three-hour search of her home, police confiscated her camera, laptop, three hard drives and all of her bank cards. The raids began at around 07:00 in Minsk, at the apartment of Barys Haretski, Press Secretary of the Belarusian Association of Journalists. He wrote on social media that the police were at his front door. He later said on the organisation's Telegram channel that when he opened the door, the police told him to put his hands behind his head and proceeded to search his home thoroughly, including, the trash cans and the refrigerator. After a three-hour search, the authorities confiscated his laptop, two phones and some money.

The authorities, also, searched the rented apartment in Homyel of Mr Andrej Stryzhak, Co-founder of the Belarus Solidarity Foundation, a fundraising initiative to support families in which the breadwinner had lost their income as a result of their protest activities. They, also, searched the apartments, belonging to Mr Strizhak's parents in Rechytsa and the parents of his former wife, Ms Yauhenia Parashchanka, who is the Press Secretary of the Barys Zvozskau Belarusian Human Rights House. They confiscated Mr Strizhak's parents' hard drive and a cell phon and Ms Parashchanka told media that the police confiscated, almost, all of her parents' savings in cash and took their bank cards, which they use to get their pensions.

Police, also, searched the office of the Belarusian Association of Journalists and held its Chairman, Mr Andrei Bastunets, for the duration of the search; the Minsk and Mahiliou offices of the Viasna Human Rights Centre and the homes of Viasna's Chairman, Mr Ales Bialiatski; the group's lawyer,

Mr Pavel Sapelka; the Co-ordinator of the Campaign against the Death Penalty, Mr Andrei Paluda and others.

In some instances, those conducting the searches used force or intimidation. The police broke open the front door of the apartment of a Viasna human rights defender, Mr Dzmitry Salauyou. When searching the house of Mr Arsenyi Bastunets, Mr Andrei Bastunets' son, eight police officers, one of them armed, told him to face the wall and told his girlfriend to lie face down on the floor.

Belarusian authorities unleashed a sweeping crackdown on peaceful protesters and their supporters in the wake of the presidential election. The authorities jailed dozens of political opposition figures, including, presidential candidates, civic activists and human rights defenders. Journalists have faced detention, ill-treatment, fines and trumped-up charges and at least 11 are currently behind bars in connection with the on-going protests. Two journalists, Ms Darya Chultsova and Ms Katsiaryna Andreyeva, are on trial on charges of 'grossly violating public order' in connection with their reporting about the protests. If, convicted, they face up to three years in prison.

The Organisation for Security and Co-operation in Europe:OSCE issued a report on November 05 concluding that the Belarus authorities committed 'massive and systemic' human rights violations before and in the aftermath of the presidential election and calling, among other things, for those responsible for torture and other abuses to be brought to justice.

"Belarusian authorities on February 16 escalated their brutal crackdown on human rights and their defenders." Mr Williamson said. "Strong action is needed in Geneva to stop this campaign and begin to restore fundamental freedoms in the country."

| | Jurisprudence | | Sri Lanka: The Government Is Suffocating Dissent and Obstructing Justice For Historic Crimes: New Amnesty Report | |

The Sri Lankan Government has launched a renewed crackdown on dissent, that is severely curtailing civil society freedom and obstructing efforts to deliver justice for conflict-era crimes under international law, said Amnesty International, in a new Report published today. The Report, 'Old Ghosts in New Garb: Sri Lanka's Return to Fear', exposes how the Sri Lankan government has targeted human rights organisations, media, lawyers, political opponents and law enforcement officers in a concerted bid to suppress opposing voices and hamper the transitional justice process for crimes, committed during the country's 30-year armed conflict.

"Over the past year, the Sri Lankan government has radically transformed the country's civic space, which is now defined by an increasing hostility and intolerance towards dissenting voices." said Mr David Griffiths, the Director of the Office of the Secretary General at Amnesty International. "People from all walks of life have been threatened, intimidated, harassed and jailed, simply, for expressing views or doing their jobs in ways, that displease the authorities. The Sri Lankan government must cease this campaign against dissent and respect its obligations under international law to protect freedom of expression, peaceful assembly and association, the right to personal security and freedom from arbitrary detention."

Since withdrawing from the UN Human Rights Council-driven justice and reconciliation process for conflict-era crimes in February 2020, the Srilankan authorities have cracked down on those

pursuing justice while deliberately hindering on-going efforts to secure justice and accountability. Amnesty International is calling on the UN Human Rights Council to implement the recommendations of a damning report on Sri Lanka, published by the UN High Commissioner for Human Rights last month, when it meets from February 22 to March 23. This includes more robust monitoring and reporting on the human rights situation and the collection and preservation of evidence for future prosecutions.

"The international community must not turn a blind eye to the deteriorating human rights situation in Sri Lanka, which is being abetted by the government's regressive moves on justice and accountability. The Human Rights Council must take steps to end the cycle of impunity by holding the Sri Lankan government fully to account and launching a new internationally agreed justice process." said Mr David Griffiths.

Amnesty International's findings show a pattern of targeting those, who have played an active role in investigating, documenting, litigating or reporting on human rights violations and abuses and advocating on behalf of the victims, including, at least, six incidents where lawyers were targeted. The country's draconian Prevention of Terrorism Act was used, among others, against Mr Hejaaz Hizbullah, a prominent minority rights advocate and lawyer, who has been detained for 10 months, without a shred of evidence of wrong-doing produced before a court.

Attorney Mr Achala Senevirathne, who appeared on behalf of families of the disappeared in an enforced disappearance case, has been threatened with violence and sexualised abuse not only on social media but also by officials accused in the case. Criminal investigators, who pursued justice for crimes under international law have, also, come under increased scrutiny. The former Director of the Criminal Investigations Department was demoted and later arrested for allegedly fabricating evidence in a case. He remains in custody and believes he is being targeted in reprisal for leading investigations in cases of abuses allegedly committed by the armed forces.

Members of the military leadership, that were in command during the last phase of the war, when allegations of human rights and humanitarian law violations are widespread, were rewarded with promotions and positions of power under the new administration, including, to civilian positions. This has had a chilling effect on victims demanding justice.

The Report, also, details how legislative amendments brought by government have undermined any credible avenues locally available for justice and how President-appointed Commissions of Inquiry are attempting to reverse accountability for perpetrators of human rights violations. The Sri Lankan government did not waste any time in introducing new instruments and techniques to muzzle dissent.

State actors have led smear campaigns against NGOs and human rights organisations, while journalists have received death threats and have been summoned for investigations and interrogations after exposing human rights abuses. Visits by state security officials to the offices of

human rights NGOs have increased over the past fourteen months. Amnesty International recorded 18 such visits in that period, during which officials made enquiries about registration details, staff and donors' bank details. Some staff members were, even, visited at their private residences.

Laws are, also, being misused to stifle free speech, including, the International Covenant on Civil and Political Rights:ICCPR Act, which was used to arrest and detain Mr Ramzy Razeek for more than five months without charge or proper access to a lawyer.

| | Europe | | Greece: Government Downplays Lead Risk at Migrant Camp | |

The Greek government is downplaying the risk of lead poisoning at a migrant camp, built in part on top of a former firing range on Lesbos island to justify its own inadequate action, Human Rights Watch said in a question-and-answer document released today. Analysis by Human Rights Watch and experts of the Greek government's testing shows the need for immediate comprehensive soil testing, blood testing for young children and safety measures to mitigate the most serious health risks.

"For seven weeks after the Greek government received test results, that showed unsafe lead levels, it took minimal action and now is continuing to downplay the risk and the need for further action." said Ms Belkis Wille, Senior Crisis and Conflict Researcher at Human Rights Watch. "Exposure to lead can cause lifelong harm and the government should listen to environmental health experts, who are advising immediate action to assess and address the full risk for residents and employees in the camp, and mitigate the harm."

On January 27, the Greek government made public a report with the results of limited tests by the Greek Institute of Geology and Mineral Exploration:EAGME at the camp in November 2020. Human Rights Watch shared those results with two environmental experts and a medical expert with a specialty in lead. The experts said that the reported testing was insufficient in scope to fully assess the extent and severity of lead contamination at the camp. They, also, noted that key elements of the methodology were not clearly described. The two environmental health experts said that the report, also, applied the wrong standards to some of the sample results, leading to a more positive conclusion than the facts warrant.

The Greek government report confirmed the presence of lead contamination in some areas of the Mavrovouni temporary migrant camp where 6,900 children, women and men are living on Lesbos. Human Rights Watch sent a letter to the Greek government in early November, calling on it to test the site because 21,000 square meters of the camp, according to the government, had been a small arms firing range from 1926 until the camp opened in September 2020. Firing ranges are well recognised as sites, contaminated by lead, which is highly toxic, particularly, to children and during pregnancy.

The fact that the Greek government-commissioned soil testing and then made the results public is a positive and necessary step to protect the health of residents and staff, Human Rights Watch said. Following the release, the government, also, committed to taking some mitigation measures, which are positive and should be pursued expeditiously.

Beyond these commitments, Human Rights Watch urges the Greek authorities to urgently undertake further comprehensive soil testing to assess the extent and severity of lead contamination throughout the camp. The authorities should inform residents, especially, people, who have young children, are pregnant or lactating, of the health risks connected to lead exposure, offer free blood lead level testing to young children living near affected areas and allow independent experts to review testing plans and measures to mitigate health risks.

The Human Rights Watch and two experts' analysis of the EAGME report shows that the government's testing approach was insufficient to fully assess the extent and severity of lead contamination at the camp. For example, when asked why only three soil samples were taken from areas most at risk of contamination, the shooting range, a researcher, involved in the testing, told representatives of non-governmental groups at a February 01 meeting that the November testing

was meant to be an initial scoping of the camp for lead levels, rather than comprehensive testing. No further testing has taken place.

The EAGME report, also, fails to address questions about the sampling methodology and soil history. When conducting further tests, the government should ensure that all relevant information about the soil history is shared with researchers and that the full methodology is made public along with results. Human Rights Watch is, also, concerned that the government downplays the risk of elevated lead levels found in two of the samples, 'MAV-1' and 'MAV-12' by incorrectly referencing less stringent Greek standards, that are applicable for industrial areas and not for a residential camp in one case and Greek residential standards instead of playground standards in the other.

Despite the severe limitations of the study, the government has used the report to support its claim that there is no risk from lead contamination at Mavrovouni camp, including, in media statements, a 'non-paper' distributed along with the report and a presentation of the summary of the findings for non-governmental groups, including, those working at the camp. Instead, the authorities should inform the residents and staff about the risks of lead poisoning and on-going testing and mitigation measures, acknowledging the current knowledge gaps.

The Greek government should immediately carry out additional comprehensive testing in the areas at high risk of contamination to help develop appropriate remediation measures, Human Rights Watch said. This should include soil at the foot of various walls formerly located within the range and the area south of sample 'MAV-1', where firing range projectiles would have landed. Prior to testing, it is vital for the government to share the scope of work with international experts for their input on field screening, sample collection and testing and potential remediation measures.

Until testing after remediation demonstrates that the soil in the area is safe, camp authorities should move the administration area, located in the vicinity of 'MAV-1' away from it, remove tents in the vicinity of 'MAV-12' and fence off the areas where contaminated soil was found near 'MAV-1' and 'MAV-12'. This would prevent young children from playing there, and protect pregnant or lactating residents receiving services and staff working in the camp.

Given the elevated lead levels found in some areas of the camp, the government should urgently offer initial blood testing for children and pregnant residents and staff working there, prioritizing children between the ages of nine months and two years, who were living in tents in the vicinity of 'MAV-12' or spending time in the administrative area of 'MAV-1'. People, who have small children or are pregnant should be informed about the risks of lead exposure and be given the opportunity to ask questions and seek advice. Protocols for seeking informed consent of parents for testing their children should be followed and parents should be given the test results. If, elevated blood lead levels are found in residents or staff they should be urgently treated.

The European Commission, which financially supports the camp, should press the Greek government to urgently conduct comprehensive testing in the areas most at risk of contamination

to help develop its remediation measures or directly commission additional independent testing. The Commission should ensure full transparency and publicly report the measures taken to protect the residents and workers in the camp from any risk of exposure to lead.

"Until further testing takes place, there is no way for anyone living or working in Mavrovouni camp to know whether they are at risk or not." Ms Wille said. "That should be a matter of concern to the European Commission, as well as, Greek authorities."

|| United Kingdom || NGOs Condemn the Appointment of William Shawcross and Announce Civil Society-Led Review of Prevent ||

Amnesty International has joined a coalition of 17 human rights and community groups saying that they will boycott the UK government's review of the anti-radicalisation programme, Prevent, in protest at the appointment of Mr William Shawcross as its Chair. In a joint letter, the organisations say: "We, the undersigned civil society organisations, express grave concern at the UK government's appointment of William Shawcross as the new reviewer of the counter-terrorism strategy Prevent. Shawcross has been appointed to replace Lord Carlile, who was removed from the post following a legal challenge last year."

"The appointments of both Shawcross and Lord Carlile have made clear, beyond doubt, that the UK government has no interest in conducting an objective and impartial review of the strategy, nor in engaging meaningfully with communities affected by it. Instead, it is apparent that the government intends to use this review to whitewash the strategy and give it a clean bill of health,

without interrogating, in good faith, its impacts on human rights and fundamental freedoms. Without these perspectives, it is impossible to impartially assess the Prevent policy." The joint letter said.

"We, the undersigned groups, can not be complicit in a process that serves only to rubber stamp a fundamentally flawed strategy. We therefore announce a collective boycott of the Prevent review. In lieu of participating in the government's review, civil society groups will conduct a parallel review that properly considers the harms of Prevent, including documenting discrimination and rights violations caused by it."

"We, and other non-governmental organisations, have long raised concerns about the discriminatory and anti-Muslim impact of Prevent and its potential to violate core human rights. Many of us were eager to provide evidence to a properly independent review, and to engage with the appointed reviewer. However, Shawcross's appointment, given his well-known record and previous statements on Islam, and following the debacle of the Carlile appointment, brings into question the good faith of the government in establishing the review and fundamentally undermines its credibility." The letter stated.

"As a director of the Henry Jackson Society, Shawcross expressed patently Islamophobic views, saying: "Europe and Islam is one of the greatest, most terrifying problems of our future. I think all European countries have vastly, very quickly growing Islamic populations." As far as we are aware, he has never publicly disavowed these comments. During the period when the Charity Commission was chaired by Shawcross, it was accused of disproportionately focusing on Muslim charities, including by putting them under investigation.

The UK government must fundamentally reconsider its flawed and counter-productive counter-terrorism strategy, which has profound and far-reaching human rights impacts. We condemn its lack of political will to carry out this crucial task—the price of which continues to be disproportionately paid by Muslims across the UK."


