|| Monday: March 15: 2021 || α . Launched in April 2020 by the World Health Organisation:WHO, the European Commission, France and The Bill and Melinda Gates Foundation, the ACT Accelerator is a partnership of leading public health agencies with equity at its heart. In under a

year, the ACT Accelerator has driven real progress to accelerate the end of the COVID-19 pandemic. It has accelerated the development of COVID-19 tests, treatments, vaccines and health systems and transformed the ability to tackle COVID-19 on a global scale but, only, if, the world can ensure the equitable distribution of these vital tools.

However, the world continues to face an unprecedented and rapidly evolving threat from COVID-19. Three major shifts in the pandemic and the operating environment for the ACT Accelerator have necessitated a refresh of ACT Accelerator priorities, financing requirements and investment case. First, COVID-19 vaccines are now available but, face acute supply constraints. Second, virus variants are emerging with increasingly concerning characteristics. Third, despite valuable support from governments, regulators, manufacturers and other stake-holders, there has been insufficient investment in global solutions to scale COVID-19 tools.

The ACT-Accelerator is well positioned to respond to these challenges. In 2020, a substantial focus was on developing and evaluating a sound product portfolio by investing in RandD, product assessment and market shaping, while laying the ground-work for large-scale procurement and in-country delivery. Now that an initial set of effective and affordable COVID-19 tools is available, resources are increasingly focused on optimising their public health impact. In 2021, ACT Accelerator aims to fully leverage these existing tools and available volumes, then expand manufacturing, while continuing to invest in further RandD and product optimisation.

The original ACT-Accelerator investment case published in September 2020 outlined a total requirement of \$38.1 billion to fully fund its work. Based on the refreshed strategic priorities outlined above, the Pillars have adjusted their resource needs. Despite generous donor contributions amounting to \$11.0 billion to date, ACT Accelerator continues to require an additional \$22.1 billion in 2021 to deliver on its full promise and fund its vital work to deliver over two billion doses of vaccines, 900 million tests and up to 100 million of new treatment courses. The publication of a more detailed Strategy and Budget outlines the detail behind these numbers.

Tackling COVID-19 requires substantial financial investments but, the financial and economic ramifications of inaction are far greater. In January 2021, a study, commissioned by the International Chamber of Commerce demonstrated that, even, with strong COVID-19 vaccine coverage in countries with high-income, inequitable access to COVID-19 tools elsewhere would cost economies with high-income an additional \$02.4 trillion in 2021 alone. Investing in ACT Accelerator dwarfs the potential multiplier benefits of domestic fiscal support investments. If, COVID-19 transmission is uncontrolled anywhere in the world, it remains a threat to everyone everywhere in the world.

Commenting on the release of the Strategy and Budget, Dr Tedros Adhanom Ghebreyesus, Director-General of WHO, said, “The ACT Accelerator has made strong progress. But new viral variants, limited vaccine supply and underinvestment have resulted in the need to refresh the strategy and budget, that chart the roadmap out of the pandemic. As we approach the one-year anniversary of the ACT Accelerator, we call on all nations to come together in global solidarity. It

isn't just the right thing to do, it is, also, the fastest and most effective way to save lives, protect health systems and restore economies."

Dr Richard Hatchett, CEO of CEPI, said, "In recent weeks COVAX has begun to turn the tide on the early inequity of the global vaccine rollout. However, with the increased spread of COVID-19 variants, we have entered a new and less predictable phase of the pandemic. It is crucial that the vaccines we have developed are shared globally, as a matter of the greatest urgency, to reduce the prevalence of disease, slow down viral mutation and bring the pandemic to an end. And in parallel, we must redouble our RandD efforts so we have the tools we need to tackle emerging variants of the virus."

Ms Emma Jannay, the Chief Access Officer and ACT-Accelerator Lead for FIND, said, "In less than a year, the ACT-Accelerator partnership has spurred the development and delivery of affordable, reliable rapid tests, scaled up manufacturing and reserved important volumes for LMICs. But while we are moving quickly, so is the virus: the emergence of new variants across the globe underscores the ongoing need for equitable access to testing and strong surveillance systems so that we are not flying blind as the pandemic evolves. Detection of flare-ups and hotspot is key to stop case numbers from rebounding during vaccine roll out."

Dr Seth Berkley, CEO of Gavi, The Vaccine Alliance, said, "Thanks to the \$06 billion committed by its donors to date, the Gavi COVAX Advance Market Commitment has been able to begin protecting at-risk groups in lower-income countries with life-saving COVID-19 vaccines. While our work is only just beginning, we can now see the benefits of a multilateral solution to this pandemic. I encourage countries and others to continue to support the ACT Accelerator's critical mission across all pillars."

The Access to COVID-19 Tools ACT-Accelerator, is the proven, up-and-running global collaboration to accelerate the development, production and equitable access to COVID-19 tests, treatments, and vaccines. It was set up in response to a call from G20 leaders in March and launched by the WHO, European Commission, France and The Bill & Melinda Gates Foundation in April 2020.

The ACT-Accelerator is not a decision-making body or a new organisation but works to speed up collaborative efforts among existing organisations to end the pandemic. It is a framework for collaboration that has been designed to bring key players around the table with the goal of ending the pandemic as quickly as possible through the accelerated development, equitable allocation and scaled up delivery of tests, treatments and vaccines, thereby protecting health systems and restoring societies and economies in the near term. It draws on the experience of leading global health organisations which are tackling the world's toughest health challenges and who, by working together, are able to unlock new and more ambitious results against COVID-19. Its members share a commitment to ensure all people have access to all the tools needed to defeat COVID-19 and to work with unprecedented levels of partnership to achieve it.

|| Life Elle || The European Medicines Agency's Safety Committee Continues the Investigation of COVID-19 Vaccine Oxford:AstraZeneca and Thrombo-embolic Events ||

Following several European countries, such as, Norway, Italy, Spain, The Netherlands, Iceland, Ireland, the latest being France and Germany, as well as, some other countries, temporarily, suspending the use of Oxford:AstraZeneca COVID-19 Vaccine, due to some reported cases where patients receiving the vaccine showing severe side effects of blood clotting and a few of them have been reported to have died of these medical incidences, the European Medicines Agency:EMA has issued a statement to make its position clear.

The statement said, "Several authorities, responsible for national vaccine campaigns in the EU countries have temporarily paused vaccination with COVID-19 Vaccine AstraZeneca. This is a precaution, taken in the light of their national situation while the European Medicines Agency:EMA

investigates a number of events of blood clots in people, who had received the vaccine, as previously reported.

Medical events, involving blood clots, some with unusual features, such as, low numbers of platelets, have occurred in a very small number of people, who received the vaccine. Many thousands of people develop blood clots annually in the EU for different reasons. The number of thrombo-embolic events overall in vaccinated people seems not to be higher than that seen in the general population. EMA is working closely with the company, with experts in blood disorders and with other health authorities, including, the UK MHRA, based on its experience with around 11 million administered doses of the vaccine.

EMA's investigation has been continuing over the weekend and rigorous analysis of all the data, related to thrombo-embolic events will be carried out in the coming days. Experts are looking in great detail at all the available data and clinical circumstances, surrounding specific cases to determine whether the vaccine might have contributed or, if, the event is likely to have been due to other causes.

EMA's safety committee:PRAC will further review the information tomorrow, Tuesday, March 16 and has called an extraordinary meeting on Thursday, March 18 to conclude on the information, gathered and any further actions, that, may, need to be taken.

The COVID-19 pandemic is a global crisis, with devastating health, social and economic impact and continues to be a major burden on EU health systems. Vaccines for COVID-19 help to protect individuals from becoming ill, especially, healthcare professionals and vulnerable populations, such as, older people or those with chronic diseases. While its investigation is ongoing, EMA currently remains of the view that the benefits of the Oxford:AstraZeneca vaccine in preventing COVID-19, with its associated risk of hospitalisation and death, outweigh the risks of side effects.

EMA will continue to communicate further as appropriate. In the meantime, anyone, who has received the vaccine and has any concerns should contact an appropriate healthcare professional. It is important that people, who suspect that they may have a side effect after vaccination report this to the national medicines regulator or to a healthcare professional, who can help them do so.

COVID-19 Vaccine Oxford:AstraZeneca is a vaccine for preventing coronavirus disease 2019:COVID-19 in people, aged, 18 years and older. COVID-19 is caused by SARS-CoV-2 virus. COVID-19 Vaccine Oxford:AstraZeneca is made up of another virus, of the adenovirus family, that has been modified to contain the gene for making a protein from SARS-CoV-2. COVID-19 Vaccine Oxford:AstraZeneca does not contain the virus itself and can not cause COVID-19.

The most common side effects with COVID-19 Vaccine Oxford:AstraZeneca are usually mild or moderate and improve within a few days after vaccination. The review of thrombo-embolic events with COVID-19 Vaccine AstraZeneca is being carried out in the context of a safety signal, under an accelerated timetable. A safety signal is information on a new or incompletely documented adverse

event, that is potentially caused by a medicine, such as, a vaccine and that warrants further investigation.

The review is being carried out by EMA's Pharmacovigilance Risk Assessment Committee:PRAC, the Committee responsible for the evaluation of safety issues for human medicines. Once the review is completed, PRAC will make any recommendations, necessary to minimise risks and protect patients' health.

|| Global Warming and Climate Change || After a Steep Drop in Early 2020, the Global Carbon Dioxide Emissions Have Rebounded Strongly ||



|| Monday: March 15: 2021 || α. The COVID-19 crisis in 2020 triggered the largest annual drop in global energy-related carbon dioxide emissions since the Second World War, according to IEA data released recently but, the overall decline of about 06% masks wide variations, depending on the

region and the time of year. After hitting a low in April, global emissions rebounded strongly and rose above 2019 levels in December.

The latest data show that global emissions were 02%, or 60 million tonnes, higher in December 2020 than they were in the same month a year earlier. Major economies led the resurgence as a pick-up in economic activity pushed energy demand higher and significant policies measures to boost clean energy were lacking. Many economies are now seeing emissions climbing above pre-crisis levels. “The rebound in global carbon emissions toward the end of last year is a stark warning that not enough is being done to accelerate clean energy transitions worldwide. If, governments don’t move quickly with the right energy policies, this could put at risk the world’s historic opportunity to make 2019 the definitive peak in global emissions.” said Dr Fatih Birol, the IEA Executive Director.

“In March 2020, IEA urged governments to put clean energy at the heart of their economic stimulus plans to ensure a sustainable recovery. But our numbers show we are returning to carbon-intensive business-as-usual. This year is pivotal for international climate action and it began with high hopes but, these latest numbers are a sharp reminder of the immense challenge we face in rapidly transforming the global energy system.”

The 2020 trends underscore the challenge of curbing emissions while ensuring economic growth and energy security. Amid a growing number of pledges by countries and companies to reach net-zero emissions by mid-century, the rebound in emissions shows what is likely to happen, if, those ambitions are not met with rapid and tangible action.

Emissions in China for the whole of 2020 increased by 0.8% or 75 million tonnes, from 2019 levels driven by China’s economic recovery over the course of the year. China was the first major economy to emerge from the pandemic and lift restrictions, prompting its economic activity and emissions to rebound from April onward. China was the only major economy that grew in 2020.

In India, emissions rose above 2019 levels from September as economic activity improved and restrictions were relaxed. In Brazil, the rebound of road transport activity after the April low drove a recovery in oil demand, while increases in gas demand in the later months of 2020 pushed emissions above 2019 levels throughout the final quarter.

Emissions in the United States fell by 10% in 2020. But on a monthly basis, after hitting their lowest levels in the spring, they started to bounce back. In December, US emissions were approaching the level seen in the same month in 2019. This was the result of accelerating economic activity, as well as, the combination of higher natural gas prices and colder weather favouring an increase in coal use.

“If, current expectations for a global economic rebound this year are confirmed and in the absence of major policy changes in the world’s largest economies, global emissions are likely to increase in 2021.” Dr Birol said. “Nonetheless, there are still reasons for optimism. China has set an ambitious carbon-neutrality target; the new US administration has re-joined the Paris Agreement and is


putting climate at the heart of its policy-making; the European Union is pushing ahead with its Green Deal and sustainable recovery plans; India’s stunning success with renewables could transform its energy future; and the United Kingdom is building global momentum toward stronger climate action at COP26 in November.”

Global emissions plunged by, almost, 02 billion tonnes in 2020, the largest absolute decline in history. Most of this, around, 01 billion tonnes, which is more than the annual emissions of Japan, was due to lower use of oil for road transport and aviation. As travel and economic activities pick up around the world, oil consumption and its emissions are rising again. The record increase in sales of electric vehicles is insufficient to off-set the growth in emissions caused by the uptick in road traffic around the world.

Global emissions from the electricity sector dropped by 450 million tonnes in 2020. This resulted partly from lower electricity demand but, also, from increases in electricity generation by solar PV and wind. For the world to achieve the climate goals of the Paris Agreement, notably of limiting global warming to well below 02 °C, a decline in electricity sector emissions of around 500 million tonnes would need to occur every single year. Even, greater annual drops in emissions from electricity generation would be required to put the world on a path in line with warming of 01.5 °C.

|| The World || Energy and Climate Leaders From Major Economies Will Attend IEA-COP26 Net Zero Summit This Month to Boost Clean Energy Momentum: March 31 ||



|| Monday: March 15: 2021 || α. High-level international energy and climate leaders from the world's largest economies will take part in the IEA-COP26 Net Zero Summit on March 31 to accelerate the momentum behind clean energy and examine how countries can work together more effectively to reduce their green-house gas emissions to net zero in line with shared international goals.

Co-hosted by IEA Executive Director Dr Fatih Birol and COP26 President Mr Alok Sharma, the Net Zero Summit is a critical milestone on the road to COP26 in Glasgow in November. The Summit will include a dynamic dialogue between the world's major economies, which are, also, large emitters, with the participation of US Presidential Special Envoy for Climate Mr John Kerry, Chinese Special Envoy on Climate Change Mr Xie Zhenhua, European Commission Executive Vice-President Mr Frans Timmermans and Indian Minister of Power, New and Renewable Energy Mr Raj Kumar Singh.

"The world's growing clean energy and climate ambitions are sending an unmistakable signal. Over 120 governments have announced their intentions to bring emissions to zero by the middle of this century. A tremendous amount now needs to be done to turn ambitions into reality: long-term targets by themselves will not suffice, as the recent rebound in global CO2 emissions shows." said Dr Birol.

"We're delighted that all the world's major players will come together at our Net Zero Summit to identify how to work together to turn targets into meaningful near-term energy actions to cut emissions and put the world on a sustainable path toward 01.5 degrees. This is vital to build momentum ahead of COP26 later this year."

"To keep our climate goals within reach the next ten years must be a decade of delivery, not deliberation. This is why the UK, as host of COP26, is pushing for much stronger international collaboration on climate change as one of its top priorities." said Mr Sharma, the COP26 President.

"The IEA-COP26 Net Zero Summit will be an important opportunity for the world's major economies to agree how they can work together to make the transition towards net zero by 2050 faster, cheaper and easier for all."

High-profile energy and climate leaders, attending the Summit, will represent countries, that together account for the vast majority of global energy demand and green-house gas emissions, including, Belgium, Brazil, Chile, Colombia, Czech Republic, Ethiopia, Germany, Greece, Italy, Japan, Kenya, Luxembourg, Mexico, Morocco, Netherlands, Norway, Poland, Slovakia and Spain.

Other global figures from business and civil society will take part alongside youth representatives. Following the opening sessions, a series of Ministerial Panels will address key issues for global clean energy transitions: Ensuring People-Centred Transitions; Catalysing Near-Term Implementation; Accelerating Technology and Innovation by Sector and Mobilising Clean Energy Investment.

The panels will be co-chaired by Ministers from governments, including, Canada, China, Denmark, India, Indonesia, South Africa, Sweden, the United Kingdom and the United States. During the closing plenary session, leaders will reflect on the major priorities for action in the run-up to COP26 in Glasgow and the subsequent IEA Ministerial Meeting and on how to strengthen the international clean energy architecture going into 2022 and beyond.


The Summit will provide a unique forum for dialogue among governments on how to implement their emissions pledges. IEA analysis shows that decisive action to boost clean energy is essential to drive sustainable recoveries worldwide over the next two to three years, setting the tone for ambitious and sustained emissions reductions through into the 2030s. Efficient multilateral mechanisms like the IEA are crucial for catalysing and supporting these efforts.

The global energy system is, even, more interconnected today than it was when the IEA was founded nearly half a century ago. And just as one country could do little on its own in response to the oil shocks, that were crippling the world economy then, governments today cannot transform the global energy system through individual efforts alone.

To help countries turn their ambitions into coherent real-world action, IEA will publish on May 18 the world's first comprehensive roadmap for the global energy sector to reach net-zero emissions by 2050. Commissioned by the UK government's COP26 Presidency, this unprecedented piece of IEA analysis will be a vital foundation for building a global consensus on reaching net-zero emissions, informing discussions at COP26 in November and beyond.

|| United Kingdom || Boris Johnson Announces £03 Billion Bus Improvement Plan: The Government to Deliver 4,000 New British-Built Electric or Hydrogen Fuelled Buses to Transition to Emission-Free Public Buses: End the Sales of New Diesel Buses: Consultation Launched on the End Date ||

The UK Prime Minister Mr Boris Johnson MP has today announced ambitious shake-up of the bus sector, which should see lower, simpler flat fares in towns and cities, turn-up-and-go services on main routes and new flexible services to reconnect communities. The Government's new bus strategy, backed by £03 billion of investment, will see passengers across England benefiting from more frequent, more reliable, easier to use and understand, better co-ordinated and cheaper bus services.

The changes announced should include simpler bus fares with daily price caps, so people can use the bus as many times a day as they need without facing mounting costs; more services in the evenings and at the weekends; integrated services and ticketing across all transport modes, so people can easily move from bus to train and all buses to accept contactless payments. Hundreds of miles of new bus lanes should make journeys quicker and more reliable, getting people out of their cars, reducing pollution and operating costs.

The Prime Minister's 10-point plan sets out how the Government will accelerate the transition to greener and more sustainable transport. The Government will deliver 4,000 new British-built electric or hydrogen buses will provide clean, quiet, zero-emission travel; transition cities and regions across England to emission-free buses, safe-guarding the UK bus manufacturing industry and end sales of new diesel buses as the Government has already launched a consultation today on the end date.

The Government expects to see local authorities and operators working together to deliver bus services, that are so frequent that passengers can just 'turn up and go', no longer needing to rely on a traditional timetable and having the confidence they won't wait more than a few minutes. Mr Boris Johnson said, "Buses are lifelines and liberators, connecting people to jobs they couldn't otherwise take, driving pensioners and young people to see their friends, sustaining town centres and protecting the environment.

As we build back from the pandemic, better buses will be one of our first acts of levelling up. Just as they did in London, our reforms will make buses the transport of choice, reducing the number of car journeys and improving quality of life for millions.

The fragmented, fully commercialised market, which has operated outside London since 1986, will end. We want to see operators and local councils enter into statutory 'enhanced partnerships' or franchising agreements to receive the new funding and deliver the improvements."

Mr Johnson went onto say that it was expected that many councils would choose enhanced partnerships, where local authorities work closely with bus companies, drawing on their operating knowledge and marketing skills. Others may decide that franchising works better for them.

"Because of the decline in use, caused by the pandemic, bus operators have already received significant emergency support from the government. From this summer, only services under these arrangements will be eligible for continued support or any new sources of funding from the £03 billion transformational investment. The government will, also, consult later this year on reforming the Bus Service Operators Grant, the current main stream of government bus funding, to achieve the same objectives."

The Transport Secretary Mr Grant Shapps said, "Buses are this country's favourite way of getting around. They help us get to school, to the GP or to the shops but services across England are patchy and it's frankly not good enough. The quality of bus service you receive shouldn't be dependent on where you live. Everyone deserves to have access to cheap, reliable and quick bus journeys.

The strategy we're unveiling today will completely overhaul services, ensuring we build back better from the pandemic. Key to it is the new deal it offers to councils, we will provide unprecedented funding but, we need councils to work closely with operators and the government, to develop the services of the future."

Mr Andy Street, the Mayor of the West Midlands, said, “Buses are the backbone of public transport in the West Midlands, carrying more than 250 million people every year. Today’s strategy is, therefore, very welcome and will enable big city regions, such as, ours to ensure buses remain at the heart of our future transport plans.”

Mr Anthony Smith, The Chief Executive of independent watchdog Transport Focus, said, “For bus passengers, today’s announcement of more frequent buses and simpler fares will be welcome news. For many, buses are a lifeline to employment, education, medical appointments and leisure and are essential to the economy. We know that the key priorities for those considering using the bus are more services running more reliably, providing better value.”

The plan, also, sets out ambitions to provide greater access to bus services for all, with plans revealed to require ‘next stop’ announcements on board buses throughout Great Britain, helping disabled passengers and others to travel with confidence. The government will, also, launch a consultation on new regulations to improve access on board buses for wheelchair users.

London-style services aren’t appropriate for all rural and suburban areas, which is why the Department for Transport is today, also, announcing the recipients of the £20 million from the government’s rural mobility fund, which enables on-demand services, such as, minibuses booked via an app, to be trialled in areas where a traditional bus service isn’t appropriate.

|| England || The Government Moves With New Measures to Provide Reassurance to Women and Girls Following the Horrific Case of Sarah Everard: We Must Drive Out Violence Against Women and Girls: Boris Johnson ||

Following a meeting of the Criminal Justice Taskforce, chaired by the UK Prime Minister, Mr Boris Johnson MP, the Government is taking immediate steps to provide further reassurance for women and girls. This includes doubling the size of the Safer Streets fund, which provides neighbourhood measures, such as, better lighting and CCTV. This will bring the funding for these local projects to £45 million, alongside a commitment from the Government to work with police forces and Police and Crime Commissioners to ensure these target areas of potential concern for women and girls and are now more focussed on preventing sexual violence. This could include targeting parks and alleyways and routes from bars, restaurants and nightclubs as the night-time economy returns in action, in line with the lifting of coronavirus restrictions. To further support this and help women feel safer in the night-time economy, the Government will,

also, roll-out pilots of 'Project Vigilant' across the country. This is an internationally award winning-approach, taken by the Thames Valley Police where both uniformed and plain clothes officers identify predatory and suspicious offenders in the night time economy.

This can involve officers attending areas around clubs and bars undercover to better ensure women are safe in these locations and increased patrols as people leave at closing time. These steps have been taken in response to the outpouring of experiences and concerns, following the murder of Sarah Everard. They will complement existing action being taken to address violence against women and girls and keep them safe.

This includes toughening sentences for serious violence and sexual assaults through the Police Crime and Sentencing Bill and measures in the Domestic Abuse Bill to improve protections for victims and create new offences, such as, non-fatal strangulation. The Prime Minister Mr Boris Johnson said, "The horrific case of Sarah Everard has unleashed a wave of feeling about women not feeling safe at night. We must do everything we can to ensure our streets are safe and we are bringing in landmark legislation to toughen sentences and put more police on the streets."

"We are, also, now taking further steps to provide greater reassurance, such as, providing better lighting and greater use of CCTV in parks and routes women may take on their walks home. Ultimately, we must drive out violence against women and girls and make every part of the criminal justice system work to better protect and defend them."

Safe-guarding Minister Ms Victoria Atkins will continue to lead on this work, alongside the Home Secretary and Women and Equalities Minister Ms Liz Truss. The Policing Minister Mr Kit Malthouse will, also, hold a summit in the coming weeks with police and industry representatives from the night-time economy on preparations to protect women as pandemic restrictions lift.

Further steps agreed in the meeting include plans to consult on the Government's intended Victims Law this Summer and £11 million in funding to provide for more Independent Sexual Violence Advisors:ISVAs to support victims through the criminal justice process.
