23 UN Special Rapporteurs Condemn the Violent Attempt at US Capitol to Overturn Election As Shocking and Incendiary ||**



|| Tuesday: January 19: 2021 || α. A group of independent UN rights experts released a statement on Monday, condemning the violent storming of the United States of America's Capitol building in

Washington DC on January 06, which they described as a shocking and incendiary attempt to overturn the results of a free and fair election. This comes as the President-Elect Mr Joe Biden and the Vice-President Elect Ms Kamala Harris head to Washington DC for the Inauguration Ceremony tomorrow, Wednesday, January 20 to begin a four-year term in office at the White House.

The US Capital is giving a sense of the city being in a siege where barricades, high barriers, blockades, closed roads and entry-points give a sense of highest sense of alert and, even, paranoia, as thousands of National Guards stand guard, following the violent attacks on the Capitol building by a violent and angry mob so that the swearing in ceremony of the new President can take place without incidents. 23 three UN Special Rapporteurs and members of Working Groups, who are unpaid volunteers, who are not UN staff, put their names to the statement, in which they strongly affirmed and expressed their solidarity with the American people, who stand for democracy, equality and the rule of law at this critical moment.

The Group announced that they stood with the democratic outcomes of the 2020 US Election, in which Mr Joe Biden was elected the 46th President of the US. They called for those, responsible for the attack and, those, who incited the violence, to be held accountable and for political leaders in the US to de-escalate tensions and unify the country in full respect for democracy and the rule of law.

The storming of the Capitol marked one of the few times in the history of the country that the building, which houses the US House of Representatives and Senate, a co-equal branch of government, along with the Presidency and Supreme Court, has been attacked. It occurred on the day that the results of the election were being certified by Senators and House representatives, in line with their constitutional duty.

In the aftermath of the attack on the Capitol and fears of further violence ahead of the inauguration of President-Elect Mr Biden on Wednesday, there has been a marked military build-up, with thousands of troops stationed in Washington DC, as well as, many important government buildings across the 50 state capitals.

The Group of experts called for the response to the violence, from the US Government, the private sector, civil society and other groups, to be consistent with freedom of expression, international

human rights standards and legal due process. Their statement affirmed the experts' hope that US democracy will emerge strengthened from the crisis, without damage to its institutions and with renewed commitment to peaceful pluralism, rule of law and democratic governance.

The Special Rapporteurs and Working Groups are part of what is known as the Special Procedures of the Human Rights Council. Special Procedures, the largest body of independent experts in the UN Human Rights system, is the general name of the Council's independent fact-finding and monitoring mechanisms, that address either specific country situations or thematic issues in all parts of the world.

Special Procedures' experts work on a voluntary basis; they are not UN staff and do not receive a salary for their work. They are independent from any government or organisation and serve in their individual capacity.

|| Tuesday: January 19: 2021 || α. The global system for pandemic alert and response is 'not fit for

purpose', highlighting the need for a new framework in the wake of COVID-19, experts appointed by the World Health Organisation:WHO said in an interim report presented on Tuesday, January 19. The Independent Panel for Pandemic Preparedness and Response found critical elements to be 'slow, cumbersome and indecisive' in an era when information about new disease outbreaks is being transmitted faster than countries can formally report on them.

"When there is a potential health threat, countries and the World Health Organisation must further use the 21st century digital tools at their disposal to keep pace with news, that spreads instantly on social media and infectious pathogens, that spread rapidly through travel." said Ms Helen Clark, the former Prime Minister of New Zealand and the Co-chair of the Panel. "Detection and alert may have been speedy by the standards of earlier novel pathogens but, viruses move in minutes and hours, rather than in days and weeks."

The Independent Panel was established to review lessons, learned from international response to COVID-19, which first emerged in Wuhan, China, in December 2019. Nearly 94 million confirmed cases and more than two million deaths have been reported globally as of Tuesday.

The Panel's second progress report said that countries were slow to respond to the new coronavirus disease, noting that there were lost opportunities to apply basic public health measures at the earliest opportunity.

Although, WHO declared on January 30, 2020 that COVID-19 was a Public Health Emergency of International Concern:PHEIC, the Panel found many countries took minimal action to prevent spread both within and beyond their borders. "What is clear to the Panel is that public health measures could have been applied more forcefully by local and national health authorities in China in January." the Report said.

"It is, also, clear to the Panel that there was evidence of cases in a number of countries by the end of January 2020. Public health containment measures should have been implemented immediately in any country with a likely case. They were not." The Report, also, outlined critical shortcomings at each phase of response, including, the failure to prepare for a pandemic despite years of warning.

"The sheer toll of this epidemic is prima facie evidence that the world was not prepared for an infectious disease outbreak with global pandemic potential, despite the numerous warnings issued that such an event was probable." the Report said.

Pandemic response has, also, deepened inequalities, according to the Panel, with inequitable access to COVID-19 vaccines a glaring example as rollout has favoured wealthy nations. "A world where high-income-countries receive universal coverage while low-income-countries are expected to accept only 20% in the foreseeable future is on the wrong footing, both for justice and for pandemic control. This failure must be remedied." said the Panel's Co chair, Ms Ellen Johnson Sirleaf, the Former President of Liberia.

The Report further highlighted the need to strengthen the UN’s health agency. “The WHO is expected to validate reports of disease outbreaks for their pandemic potential and, deploy support and containment resources, but, its powers and funding to carry out its functions are limited.” Ms Sirleaf said. “This is a question of resources, tools, access, and authority.”

Countries are, also, urged to ensure testing, contact tracing and other public health measures to reduce virus spread, are being implemented, in efforts to save lives, particularly, as more infectious virus variants emerge.

The Independent Panel began its review last September and will present a Report to the World Health Assembly, WHO’s decision-making body, in May.

|| Africa || Libya: The Libyan Political Dialogue Forum Reaches A Breakthrough on an Interim Leadership For a Temporary Executive ||



|| Tuesday: January 19: 2021 || á. Announcing the development on Saturday, Acting UN Libya Envoy Ms Stephanie Williams said that Libyan envoys, who had travelled to the Swiss city had

broken the deadlock over selecting representatives for a temporary executive, from all regions of the country. The oil-rich nation has been divided into warring factions since the overthrow of President Muammar Gaddafi in 2011, with bloody conflict between the UN-recognised Government of National Accord:GNA in the west and the Libyan National Army:LNA in the east.

The terms of the Geneva deal were due to be voted on today, Monday, by the 75 members of the Libyan Political Dialogue Forum, in Tunis. The UN Secretary-General Mr António Guterres has praised the breakthrough, made by a key committee of the Libyan Political Dialogue Forum at the weekend, over an interim political leadership deal, ahead of nationwide elections at the end of the year.

Ms Williams described the proposal as ‘the best possible compromise’ as it respected the regional dimension and encouraged people to work across the divide and across regions, in order to strengthen understanding and to build unity in the country’. The temporary authority will be replaced by a permanent, democratically elected government, chosen by the Libyan people.

“It is important to reflect and to remind everyone that what we are talking about here is a temporary, unified executive authority, that will be replaced by a permanent, democratically elected government, chosen by the Libyan people on December 24th of this year.” Ms Williams said.

Mr Guterres commended in particular the ‘decisive role, played by women representatives and the Southern members, to forge consensus’ over a recommended mechanism for selecting the executive. The Secretary-General called on the members of the Libyan Political Dialogue Forum to participate constructively in the vote on the selection mechanism and press ahead on the path to national elections.

Mr Guterres, also, reiterated the support of the entire UN for the people of Libya, in their efforts to advance peace and stability. He, also, made the formal announcement on Monday that Mr Ján Kubiš of Slovakia was to be the new Special Envoy on Libya and Head of the Support Mission in Libya:UNSMIL.

Mr Guterres said that he was grateful for the commitment and outstanding leadership of Acting Special Representative Ms Stephanie Williams, who had moved the political process of reconstituting the war-torn country forward considerably during her time in the key role.

Mr Kubiš, who has served as Special Co-ordinator for Lebanon, Office of the UN Special Co-ordinator for Lebanon:UNSCOL, since 2019, brings with him many years of experience in diplomacy, foreign security policy and international economic relations, both internationally and in his own country.

|| The Humanion || Lebanon: Dire Conditions For Syrian Refugees in Border Town ||

Syrian refugees in Aarsal, a Lebanese town on the border with Syria, do not have adequate shelters to withstand the harsh winter months, Human Rights Watch said today, releasing a video showing their dire living conditions. More than 15,000 Syrian refugees in Aarsal are experiencing their second winter since a 2019 order from the Higher Defense Council, which is chaired by the President and responsible for implementing national defense strategy, required them to dismantle their shelters.

The order has forced them to live without adequate roofs and insulation, exposed to harsh winter conditions, including, sub-zero temperatures and flooding. “Living conditions for the Syrian refugees living in Aarsal forced to dismantle their shelters in 2019 remain dire.” said Ms Michelle Randhawa, the Refugee and Migrant Rights Senior Co-ordinator at Human Rights Watch. “Their situation, compounded by Covid-19 movement restrictions, threatens their safety and their very

lives.” In November and December 2020, Human Rights Watch researchers returned to Aarsal to interview seven refugees, first interviewed during the summer of 2019 to assess the impact of the demolitions on their standard of living and, in particular, on their access to adequate shelter during the winter months.

The refugees described dire living conditions. They, also, said that they lacked information and resources to prevent the spread of Covid-19. All seven refugees, interviewed, described harsh weather conditions and inadequate building materials. Due to flooding and heavy rains, four said that mould had formed on the wood, used to rebuild the top portions of the shelters. A few said that the mould caused health problems for children and asthmatic relatives.

“An NGO gave us one tarp to cover the roof and we had to buy the rest ourselves.” said a Syrian refugee from Homs, who said that her daughter coughed because of the mould. “We just have five cinderblocks of protection, the rest is wood. The water comes from under the walls. There is a smell coming from the mould.”

Aarsal is in the Bekaa Valley, a mountainous region on the border with Syria, known for harsh winters. Last winter a storm had a devastating impact in Aarsal. Refugees, who had been forced to dismantle their shelters seven months earlier were left with plywood and tarp roofs to shield them from the heavy snow and extreme wind. Temperatures reported at that time were as low as minus 10 degrees Celsius.

The 2019 Higher Defense Council order is based on the Lebanese Construction Law Act, No. 646. The Construction Law stipulates that only ‘non-permanent’ building materials, including, wood, stone and canvas, can be used for building on agricultural land and that full concrete structures, including, cement foundations, are not allowed. While the Construction Law Act has been on the books since 2004, it had remained largely unenforced until the 2019 order.

Building materials for upper walls and roofs can only consist of wood and tarp. The 2019 order permits a foundation five cinderblocks high or about one metre, for shelters in Aarsal. In the rest of the country, hard foundations can be no higher than two cinderblocks. The order was first implemented in Aarsal, where Syrian refugees were given a deadline of July 01, 2019 to dismantle their shelters or risk having the Lebanese Army demolish them.

On the July 01 deadline, the Lebanese Army bulldozed 20 non-compliant shelters. Refugees in Akkar, in northern Lebanon, were given until August 07, 2019. On August 08, the Lebanese Army partially demolished 350 non-compliant shelters in Akkar. Since clashes in Aarsal in 2014, involving the Lebanese Army, Daesh and Jabhat al-Nusra, a listed armed group now part of an armed coalition, known as, Hay’et Tahrir al-Sham, the Lebanese Army has conducted frequent military raids on refugee camps there. Aarsal and the camps, located within its borders, are now surrounded by military checkpoints, restricting movement in and out of the town and the refugee camps.

Tensions have flared periodically between some members of Lebanese host communities and some refugees since the Syrian civil war began, almost, a decade ago. In November 2020, a Syrian refugee, allegedly, killed a Lebanese resident of Bcharre, a town in the North Governorate of Lebanon, two hours from Aarsal. Soon after, a group of Lebanese residents demanded the eviction of Syrians from the area and set fire to refugee homes in the town. Hundreds of Syrian refugees, subsequently, fled.

At the end of December, a fight between a Lebanese family and Syrian workers in Minyeh, just north of Tripoli, led some Lebanese residents to set fire to a nearby Syrian refugee camp, displacing hundreds. Humanitarian response programmes for Syrian refugees in Lebanon, that provide shelter, are massively underfunded. According to the 2020 Update of the Lebanon Crisis Response Plan, a joint effort between the Lebanese government and local and international partners to address the needs of vulnerable populations in Lebanon, groups providing shelter, needed, roughly, \$155.6 million. As of November, they had, only, been able to fund \$27 million, just 17%.

Due to Lebanon's rapid inflation, Syrian refugees there have faced soaring prices and rents, sometimes forcing them to choose between buying food and essential items and paying bills. The preliminary 2020 findings of the Vulnerability Assessment of Syrian Refugees in Lebanon, conducted, jointly by World Food Programme, the United Nations refugee agency UNHCR and UNICEF, show that the economic crisis and the COVID-19 pandemic have pushed 89% of the Syrian refugee population in Lebanon below the extreme poverty line.

Half of the Syrian refugee population in Lebanon is now food insecure. Three of the refugees Human Rights Watch spoke with, raised concern with rising costs to send children to school, rents and electricity. "We pay more rent than before now." said a Syrian refugee from Damascus. "We used to pay 125,000 pounds:LBP per month and now we pay 300,000 pounds per month because of the situation."

All of the Syrian refugees, interviewed raised concerns about the lack of information and resources available to them to prevent the spread of COVID-19. Three said that since the beginning of the pandemic, they were, only, visited once by an aid group, which gave them some masks and disinfectants. Most refugees said that they did not know whom to contact or what to do in case someone in their family develops symptoms. "At the beginning they gave us a box of supplies for COVID-19," the refugee from Damascus said. "They came just one time. If, someone is sick, there are no doctors to call."

Since early March, Lebanese municipalities have used the COVID-19 pandemic to impose discriminatory curfews and movement restrictions, that apply only to Syrian refugees. Most of those, interviewed, expressed concerns regarding their ability to access health resources and essential supplies amid these discriminatory restrictions and stigma. "The difference between us and the Lebanese, who live here is that we can't leave our homes." the refugee from Homs said.

The worsening economic crisis, the devastating Beirut port explosion and COVID-19 have overwhelmed Lebanon's health sector. Hospitals are, almost, at capacity as healthcare workers warn of a COVID-19 catastrophe'. UNHCR and its partner organisations have set up COVID-19 response plans for Lebanon's refugee populations but, information sharing varies across regions. UNHCR said that it would, only, cover the cost of testing and treatment, if, a refugee has first contacted the Health Ministry's hotline and followed its instructions. Despite their dire living conditions, none of the Syrian refugees, interviewed, said it was safe enough for them to return to Syria.

The Lebanese government and donor organisations and governments should ensure that everyone's right to adequate housing is fully protected, Human Rights Watch said. This should include increased support for winterising the homes of Syrian refugees to protect vulnerable families from harsh weather and to enable them to live in safety and dignity. Donors should, also, continue to urge the Lebanese government to review its policies on materials permitted in informal settlements and to allow the distribution of more sustainable shelter materials. "Facing inadequate shelter, COVID-19 restrictions and rampant inflation, Lebanon's Syrian refugee population urgently needs assistance, especially, during these harsh winter months." Ms Randhawa said.

|| United Kingdom || All Homes and Businesses Will Have to Meet Rigorous New Standards to Lower Energy Consumption Bills and to Protect the Environment in the UK ||

All homes and businesses will have to meet rigorous new energy efficiency standards to lower energy consumption and bills, helping to protect the environment, the Housing Minister Mr Chris Pincher has announced today, Tuesday, January 19. Responding to a consultation on the Future Homes Standard, the government has set out plans to, radically, improve the energy performance of new homes, with all homes to be highly energy efficient, with low carbon heating and be zero carbon ready by 2025.

These homes are expected to produce 75-80% lower carbon emissions compared to current levels. To ensure industry is ready to meet the new standards by 2025, new homes will be expected to produce 31% lower carbon emissions from 2021. Existing homes will, also, be subject to higher standards, with a significant improvement on the standard for extensions, making homes warmer and reducing bills. The requirement for replacement, repairs and parts to be more energy efficient. This includes the replacement of windows and building services, such as, heat pumps, cooling systems or fixed lighting.

The Government plans, also, include other measures: Ventilation: a new requirement for additional ventilation and indoor air quality monitoring in high-risk non-domestic buildings, such as, offices and gyms, reducing the risk of any potential infections being spread indoors. Overheating in residential buildings: a new overheating mitigation requirement in the Building Regulations.

There will be stringent transitional arrangements in place to provide all developers with certainty about the standards they are building. These will last for one year and apply to individual homes, rather than an entire development. The Government has, also, announced a consultation on higher performance targets for non-domestic buildings, which will mean they will be zero carbon ready by 2025.

The Housing Minister Mr Christopher Pincher MP said, "Improving the energy performance of buildings is vital to achieving net-zero emissions by 2050 and protecting the environment for future generations to come. The radical new standards announced today will not only improve energy efficiency of existing homes and other buildings but, will, also, ensure our new homes are fit for the future, by reducing emissions from new homes by at least 75%."

"This will help deliver greener homes and buildings, as well as, reducing energy bills for hard-working families and businesses. The Government is committed to reaching net-zero and is taking considerable action to address the emissions from buildings, with heating and powering buildings currently accounting for 40% of the UK's total energy usage.

There has, already, been considerable progress made on emissions from homes, with overall total emissions reduced by about a fifth since 1990 despite there being, approximately, a quarter more homes. In 2019 the Government introduced a legally binding target to reduce greenhouse gas emissions to net zero by 2050, making the UK the first major economy in the world to legislate a zero net emissions target. The measures announced today recognise the important role that the

energy efficiency of buildings can play in achieving this goal. Taken together these measures will help to lower the cost of energy bills for families, while helping to tackle our climate change goals.” he said.

The Government has published its response to the Future Homes Standard consultation, which sought views on how best to improve the energy performance of new homes. This was the first part of a two-part consultation on Part L and Part F of the Building Regulations. Additionally, new plans to make all other buildings, including, existing homes, more energy efficient have been published today as part of the Future Buildings Standard consultation.

|| England || NHS England Opens Ten New COVID Vaccination Sites Across the Country in As Diverse Places As Rugby Ground Racecourse Food Court and Cathedral ||

The NHS staff have started delivering COVID vaccinations at a rugby ground, racecourse, food court and cathedral from yesterday as the biggest immunisation programme in health service history grows. Ten new large-scale Vaccination Centres, capable of immunising thousands of people a week, are opening their doors in every health region across the country.

The new sites mean that there will be 17 Vaccination Centres, offering people an alternative to GP-led and hospital services, with more to follow. There are, already, around, 1,200 hospitals and GP-

led services with newly published figures, showing the NHS has delivered more than 03.79 million jabs so far, including, vaccinating more than one in three people, aged, 80 and over. The new sites will help to ensure that everyone in England is in easy reach of a vaccination service, including, rural parts of the country like Boston and Norwich.

Last week NHS in England vaccinated 140 people every minute and hopes to do, even, more people this week as vaccine becomes available. Professor Stephen Powis, NHS England's Medical Director, said, "The NHS vaccination programme has got off to a strong start with our hard-working staff, delivering more than three million vaccinations, while, also, dealing with the latest wave of coronavirus infections."

"This is accelerating as more vaccine supplies come on stream with more sites, opening all the time so that we can protect as many people as swiftly as possible. The rapid progress we have, already, made is testament to NHS staff, who are pulling out all the stops to vaccinate the most vulnerable while caring for so many people who are seriously ill with COVID. In the most challenging of circumstances we are seeing the very best of the NHS." he said.

The 10 new sites, that opened from Monday, January 18 are: Bournemouth International Centre, Taunton Racecourse, Blackburn Cathedral, Salt Hill Activity Centre, Slough, Norwich Foodcourt, Castle Quarter, The Lodge, Wickford, Essex, Princess Royal Sports Arena, Lincolnshire, St Helens Rugby Ground, Park and Ride at Askham Bar, York and Olympic Office Centre, Wembley, London.

More than a million letters have gone out to people, aged, 80 and over, inviting them to make an appointment at Vaccination Centre or pharmacy service. Anyone, who can not or does not want to travel, can wait to be vaccinated by their local GP service or hospital. Nobody needs to contact the NHS, as people will be invited when it is their turn and people can not get vaccinated by just turning up.

Appointments are staggered to allow for social distancing and people are urged not to turn up early to avoid queues. The new vaccine centres will each be capable of delivering thousands of jabs each week but, scaling up and down according to vaccine supplies and demand. If, anyone invited has received a jab since the letter was sent out or would prefer to wait to be invited to attend a hospital or GP service they can simply ignore it.

Those like care home residents, who are unable to travel to vaccine centres, hospitals or GP-led sites are, already, being immunised at home. Health and care staff are, also, being vaccinated at the 17 centres. People, who book in to a vaccine centre will be greeted by volunteers, who will marshal carparks and register them when they arrive.

They will receive a health status check and a pre-vaccination assessment before they have their vaccine injection. The process should take well under an hour. The NHS made history when Ms Maggie Keenan became the first person in the world to be protected against coronavirus outside of a clinical trial when she received the Pfizer vaccine at Coventry Hospital on December 08. The NHS

was, also, the first health system to deliver the new Oxford AstraZeneca coronavirus vaccine when Mr Brian Pinker, 82, had it earlier this month.

|| England || The Local Government and Social Care Ombudsman Finds: A Mother Was Left With No Respite or Protection From Her Disabled Son by Somerset County Council ||

Three young children were left without any protection from their violent older brother after Somerset County Council failed to help their family, the Local Government and Social Care Ombudsman has found. The older brother, whose Special Educational Needs and condition means he is prone to sudden, unpredictable and violent outbursts, was significantly bigger and heavier than his mother and younger siblings.

Because the mother struggled to cope with her son's condition and, also, protect her younger children, she asked the council to consider placing him in a residential school. Between 2015 and 2018, specialists, working with the family, witnessed the brother hitting and kicking his siblings and throwing and using objects against them. The siblings suffered physical injuries and were afraid of their older brother, often, hiding to avoid him.

Reports to the Council from his school showed the boy had punched a child in the face and attempted to strangle a fellow pupil. A specialist nurse reported that the school had recorded 36 separate incidents of violence, involving the boy. In another incident, a specialist nurse, visiting the family, had to intervene to rescue the mother when the older boy sat on her, pinning her down. The same nurse witnessed an unprovoked attack on the boy's sister where he struck her with an object. She said that the level of support, provided at the time was not sufficient to protect the siblings from further harm.

The boy was finally provided with a 52-week residential placement in May 2018. The Ombudsman's investigation found that the Council had failed to provide the respite it had assessed the family as needing for nearly three years. It, also, found that the Council did not do enough to assess the risk the brother posed to the younger siblings, despite several reports from professionals and repeated calls from their mother that they were suffering both physical and psychological harm while their mother was unable to protect them.

Mr Michael King, the Local Government and Social Care Ombudsman, said, "Throughout the three years the Council had a wealth of evidence both the mother and the boy's school, struggled to cope with the boy's violent and unpredictable outbursts. Despite this, it sought to blame the mother's parenting style rather than provide the respite the Council itself assessed the family as needing.

This left the family suffering both physical and psychological distress: the children have had to unlearn three years of coping behaviours and the family was unable to enjoy quality time together. I am pleased the Council has now agreed to my recommendations and hope the changes they have agreed to make will ensure disabled children and their families are safeguarded appropriately in future."

The Local Government and Social Care Ombudsman's role is to remedy injustice and share learning from investigations to help improve public and adult social care, services. In this case the Council has agreed to apologise to the mother and pay her £8,250. This is made up of £2,000 for the injustice she suffered and £2,000 each for the younger children for the injustice they had to endure and £250 for the older boy, to benefit the children.

The Ombudsman has the power to make recommendations to improve processes for the wider public. In this case the Council has agreed to remind all social care staff that children have the right to be protected and that that section 47 of the Children Act 1989 should not be ruled out and could be appropriate in exceptional circumstances when providing support to disabled children and their families. It will, also, remind those responsible for the conduct of placement panels that there, must, always, be a record of what information they consider and their rationale for those decisions.

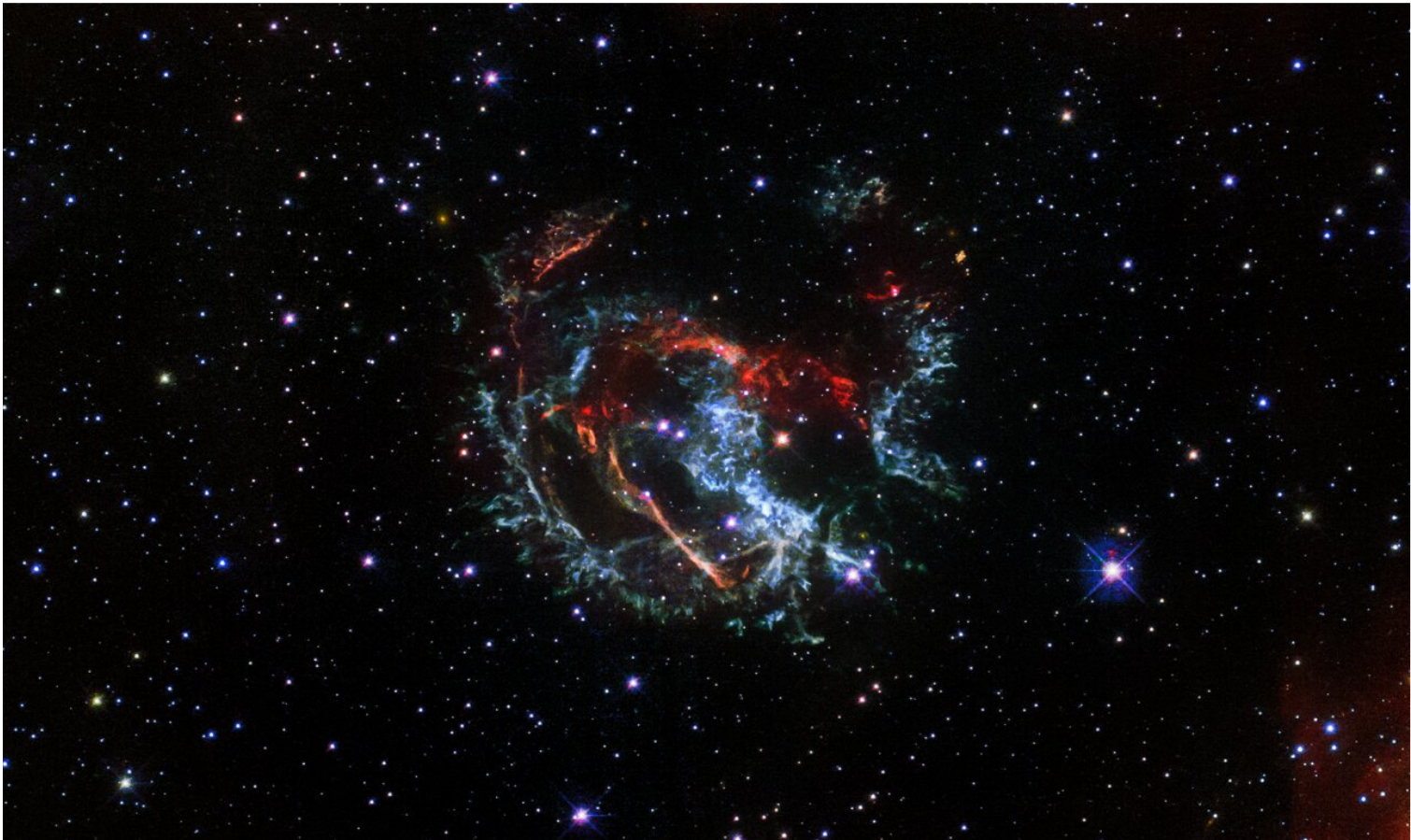

|| Tuesday: January 19: 2021 || á. The NASA:ESA Hubble Space Telescope has observed the supernova remnant, named, 1E 0102.2-7219. Researchers are using Hubble's imagery of the remnant object to wind back the clock on the expanding remains of this exploded star in the hope of understanding the supernova event, that caused it 1,700 years ago.

The featured star, that exploded long ago, belongs to the Small Magellanic Cloud, a satellite galaxy of our Milky Way, located, roughly, 200,000 light-years away. The doomed star left behind an expanding, gaseous stellar corpse, a supernova remnant, known as, 1E 0102.2-7219. Because the gaseous knots in this supernova remnant are moving at different speeds and directions from the supernova explosion, those, moving toward Earth are coloured blue in this composition and the ones moving away are shown in red.

This new Hubble image shows how these ribbons of gas, speeding away from the explosion site at an average speed of 03.2 million kilometres per hour. At that speed, you could travel to the Moon and back in 15 minutes. Researchers have studied the Hubble archive, looking for visible-light images of the supernova remnant and they have analysed the data to calculate a more accurate estimate of the age and centre of the supernova blast.

According to their new estimates, light from this blast arrived at Earth 1,700 years ago, during the decline of the Roman Empire. This supernova would, only, have been visible to inhabitants of Earth's southern hemisphere. Unfortunately, there are no known records of this titanic event. Earlier studies proposed explosion dates of 2,000 and 1,000 years ago but, this new analysis is believed to be more robust.

To pinpoint when the explosion occurred, researchers studied the tadpole-shaped, oxygen-rich clumps of ejecta flung out by this supernova blast. Ionised oxygen is an excellent tracer because it glows brightest in visible light. By using Hubble's powerful resolution to identify the 22 fastest moving ejecta clumps or knots, the researchers determined that these targets were the least likely to have been slowed down by passage through interstellar material.

They, then, traced the knots' motion backward until the ejecta coalesced at one point, identifying the explosion site. Once that was known, they could calculate how long it took the speedy knots to travel from the explosion centre to their current location. Hubble, also, measured the speed of a suspected neutron star, the crushed core of the doomed star, that was ejected from the blast. Based on the researchers' estimates, it must be moving at more than 03 million kilometres per hour from the centre of the explosion to have arrived at its current position. The suspected neutron star was identified in observations with the European Southern Observatory's Very Large Telescope in Chile, in combination with data from NASA's Chandra X-ray Observatory.

The international team of astronomers, who carried out this study, consists of J Banovetz, D Milisavljevic, N Sravan, R A. Fesen, D J Patnaude, P P Plucinsky, W P Blair, K E Weil, J A Morse, R Margutti and M R Drout.

The Hubble Space Telescope observations, involved in this study, are associated with programmes 6052 Morse, 12001 Green, 12858 Madore and 13378 Milisavljevic. These results have been presented at the 237th American Astronomical Society virtual meeting on January 14, 2021 and will be published in the Astrophysical Journal.
